Section 1. Minnesota Statutes 2012, section 363A.36, subdivision 1, is amended to read: 1.6 Subdivision 1. Scope of application. (a) For all contracts for goods and services in 1.7 excess of \$100,000, no department or agency of the state shall accept any bid or proposal 1.8 for a contract or agreement from any business having more than 40 full-time employees 1.9 within this state on a single working day during the previous 12 months, unless the 1.10 commissioner is in receipt of the business' affirmative action plan for the employment of 1.11 minority persons, women, and qualified disabled individuals. No department or agency of 1.12 the state shall execute any such contract or agreement until the affirmative action plan 1.13 has been approved by the commissioner. Receipt of a certificate of compliance issued by 1.14 the commissioner shall signify that a firm or business has an affirmative action plan that 1.15 has been approved by the commissioner. A certificate shall be valid for a period of two 1.16 years. A municipality as defined in section 466.01, subdivision 1, that receives state 1.17 money for any reason is encouraged to prepare and implement an affirmative action plan 1.18 for the employment of minority persons, women, and the qualified disabled and submit the 1.19 plan to the commissioner. 1.20

## 5000.3560 PROCEDURES FOR ISSUING CERTIFICATES OF COMPLIANCE.

Subp. 2. Certificates issued. Except as provided in subpart 3, certificates of compliance shall be issued within 30 days after the department has received the information required in subpart 1.

### 5000.3560 PROCEDURES FOR ISSUING CERTIFICATES OF COMPLIANCE.

Subp. 3. **Insufficient information.** A business or firm whose submission does not meet the requirements of subpart 1 shall be notified within 15 days that its submission must be revised. The notification shall state specifically how the submission fails to meet the requirements of subpart 1. Certificates of compliance shall be issued 15 days after the department has received a revised submission which complies with subpart 1.
