1.5	Section 1. Minnesota Statutes 2014, section 120B.236, is amended to read:
1.6	120B.236 CARDIOPULMONARY RESUSCITATION AND AUTOMATIC
1.7	EXTERNAL DEFIBRILLATOR INSTRUCTION.
1.8	(a) School districts must provide onetime cardiopulmonary resuscitation and
1.9	automatic external defibrillator instruction as part of their grade 7 to 12 curriculum for
1.10	all students in that grade beginning in the 2014-2015 school year and later. Training and
1.11	instruction provided under this section need not result in cardiopulmonary resuscitation
1.12	certification. Cardiopulmonary resuscitation and automatic external defibrillator
1.13	instruction must include cardiopulmonary resuscitation and automatic external defibrillator
1.14	training that has been developed:
1.15	(1) by the American Heart Association or the American Red Cross and incorporate

Cross, among others, to provide instruction and training under this section. Community members are encouraged to provide needed training and instructional resources such as cardiopulmonary resuscitation kits and other materials at no cost to the school districts. A school administrator may waive this curriculum requirement for a high school transfer student regardless of whether or not the student previously received instruction under this section, an enrolled student absent on the day the instruction occurred under this section, or an eligible student who has a disability. If a school district requests resources, the Minnesota Resuscitation Consortium must provide them to the district for instruction and training provided to students under this section.

(c) At any public event held at a school facility or on school grounds, before the event begins and when practicable, the person in charge of the event must arrange to announce, via a public announcement system, to the public the location of any nearby automatic external defibrillators. This requirement shall also apply to a person in charge of a school-sponsored event that is held at a private or public facility that has been rented for the purpose of a school event.
