1.6 requirements for covered farm vehicles; extending an expiration date; providing
1.7 an hours of service exemption; requiring user financing for a certain parking

1.19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.20 Section 1. Minnesota Statutes 2012, section 16A.124, subdivision 5, is amended to read:

1.21 Subd. 5. Payment of interest on late payments required. (a) A state agency
1.22 shall pay interest to a vendor for undisputed billings when the agency has not paid the
1.23 billing within 30 days following receipt of the invoice, merchandise, or service whichever
1.24 is later. A negotiated contract or agreement between a vendor and a state agency which
1.25 requires an audit by the state agency prior to acceptance and payment of the vendor's
1.26 invoice shall not be considered past due until 30 days after the completion of the audit by
1.27 the state agency. Before any interest payment is made, the vendor must invoice the state
1.28 agency for such interest. For a construction contract utilizing partial payments based on an
1.29 engineer's estimate or a payment application approved by an architect, an invoice includes

2.1 an engineer's estimate or a payment application, as applicable, if made in regular intervals
2.2 that are: (1) as specified in the contract, and (2) no less frequent than once per month.

2.3 (b) The rate of interest paid by the agency on undisputed bills not paid within 30
2.4 days shall be 1-1/2 percent per month or any part thereof.

2.5 (c) All interest penalties and collection costs must be paid from the agency's current
2.6 operating budget. No agency may seek to increase its appropriation for the purpose of
2.7 obtaining funds to pay interest penalties or collection costs.

2.8 (d) Any vendor who prevails in a civil action to collect interest penalties from a state
2.9 agency shall be awarded its costs and disbursements, including attorney's fees, incurred
2.10 in bringing the actions.

2.11 (e) No interest penalties may accrue against an agency that delays payment of a bill
2.12 due to a disagreement with the vendor; provided, that the dispute must be settled within 30
2.13 days after the bill became overdue. Upon the resolution of the dispute, the agency must
2.14 pay the vendor accrued interest on all proper invoices for which payment was not received
2.15 within the applicable time limit contained in subdivision 3. No interest penalties accrue
2.16 under this section against an agency for claims made by a contractor under a construction
2.17 contract.

2.18 (f) The minimum monthly interest penalty payment that a state agency shall pay a
2.19 vendor for the unpaid balance for any one overdue bill equal to or in excess of \$100 is
2.20 \$10. For unpaid balances of less than \$100, the state agency shall pay the actual penalty
2.21 due to the vendor.

2.22 Sec. 2. Minnesota Statutes 2012, section 161.14, is amended by adding a subdivision
2.23 to read:

2.24 Subd. 76. **Michael Duane Clickner Memorial Bridge.** The bridge over the
2.25 Mississippi River on marked Trunk Highway 60 at the city of Wabasha, is designated
2.26 "Michael Duane Clickner Memorial Bridge." The commissioner of transportation shall
2.27 adopt a suitable design to mark this bridge and erect appropriate signs, subject to section
2.28 161.139.

2.29 Sec. 3. Minnesota Statutes 2012, section 161.32, subdivision 5, is amended to read:

2.30 **Subd. 5. Default by contractor.** In cases where work is being done under contract
2.31 and the commissioner finds that the contractor has failed to comply within ~~60 days~~ the
2.32 period specified in the contract from the date of receipt of a written demand to make
2.33 arrangements, satisfactory to the commissioner, to correct specified delays, neglect, or
2.34 default, within the control of the contractor, the commissioner may negotiate with others,

3.1 with the approval of the defaulting contractor's surety, for the completion of the contract
3.2 according to the terms and provisions of the contract.

3.3 Sec. 4. Minnesota Statutes 2013 Supplement, section 161.44, subdivision 1a, is
3.4 amended to read:

3.5 Subd. 1a. **Periodic review.** (a) The commissioner is encouraged to examine all real
3.6 property owned by the state and under the custodial control of the department to decide
3.7 whether any real property may be suitable for sale or some other means of disposal.

3.8 (b) The commissioner may not sell or otherwise dispose of property under this
3.9 subdivision unless: (1) an analysis ~~has been performed of suitability of the property~~
3.10 ~~for bicycle or pedestrian facilities, which must take into account~~ consider any relevant
3.11 nonmotorized transportation plans or in the absence of such plans, demographic and
3.12 development factors affecting the region; ~~and (2) the analysis,~~ demonstrates that (i) the

3.21 Sec. 5. Minnesota Statutes 2012, section 162.06, subdivision 1, is amended to read:

3.22 Subdivision 1. **Estimate.** (a) By December 15 of each year the commissioner shall
3.23 estimate the amount of money that will be available to the county state-aid highway
3.24 fund during that fiscal year. The amount available must be based on actual receipts ~~from~~
3.25 ~~July 1 through October 31,~~ at the time of the allocation calculation, the unallocated fund
3.26 balance, and the projected receipts for the remainder of the fiscal year. The amount
3.27 available, except for deductions as provided in this section, shall be apportioned by the
3.28 commissioner to the counties as provided in section 162.07.

3.29 (b) For purposes of this section, "amount available" means the amount estimated in
3.30 paragraph (a).

3.31 Sec. 6. Minnesota Statutes 2012, section 162.081, subdivision 4, is amended to read:

3.32 Subd. 4. **Formula for distribution to towns; purposes.** (a) Money apportioned to
3.33 a county from the town road account must be distributed to the treasurer of each town

4.1 within the county, according to a distribution formula adopted by the county board.
4.2 The formula must take into account each town's ~~levy for road and bridge purposes,~~ its
4.3 population and town road mileage, and other factors the county board deems advisable
4.4 in the interests of achieving equity among the towns. Distribution of town road funds
4.5 to each town treasurer must be made by March 1, annually, or within 30 days after
4.6 receipt of payment from the commissioner. Distribution of funds to town treasurers in a
4.7 county which has not adopted a distribution formula under this subdivision must be made
4.8 according to a formula prescribed by the commissioner by rule.

4.9 (b) Money distributed to a town under this subdivision may be expended by the
4.10 town only for the construction, reconstruction, and gravel maintenance of town roads

4.13 Subdivision 1. **Estimate of accruals.** By December 15 of each year the
4.14 commissioner shall estimate the amount of money that will be available to the municipal
4.15 state-aid street fund during that fiscal year. The amount available is based on actual
4.16 receipts ~~from July 1 through October 31,~~ at the time of the allocation calculation, the
4.17 unallocated fund balance, and the projected receipts for the remainder of the fiscal year.
4.18 The total available, except for deductions as provided herein, shall be apportioned by the
4.19 commissioner to the cities having a population of 5,000 or more as hereinafter provided.

4.20 Sec. 8. Minnesota Statutes 2012, section 165.03, subdivision 3, is amended to read:

4.21 Subd. 3. **County inventory and inspection records and reports.** The county
4.22 engineer shall maintain a complete inventory record of all bridges as set forth in subdivision
4.23 2, paragraph (b), clause (2), with the inspection reports thereof, and shall certify annually
4.24 to the commissioner, as prescribed by the commissioner, that inspections have been made
4.25 at regular intervals, not to exceed the intervals outlined in subdivision 1a. A report of the
4.26 inspections must be filed annually, on or before February 15 of each year, with the county
4.27 auditor or town clerk, or the governing body of the municipality. The report must ~~contain~~
4.28 ~~recommendations for the correction of or~~ identify any deficiency requiring action, including
4.29 the legal posting of load limits or the need to have a load rating analysis performed, on any
4.30 bridge or structure that is found to be understrength or unsafe. The report may also contain
4.31 other recommendations for improving the safety of understrength or unsafe bridges.

4.32 Sec. 9. Minnesota Statutes 2012, section 165.12, subdivision 1, is amended to read:

5.1 Subdivision 1. **Duty Authority of county when town fails.** (a) Notwithstanding
5.2 any law to the contrary, a county has the following authority regarding town bridges
5.3 within its jurisdictional boundaries.

5.4 (b) When it becomes necessary to reconstruct or repair a bridge on any town road
5.5 in any town or upon any town line in this state, and the bridge is unsafe for travel or has
5.6 been condemned by the proper authorities, and the town or towns charged with the duty of
5.7 maintaining the bridge fail, neglect, or omit to construct, reconstruct, or repair the same or
5.8 provide for the expense or cost of so constructing, reconstructing, or repairing the same, as
5.9 identified in the report provided to the town or towns under section 165.03, subdivision
5.10 3, the county board of the county in which the town or towns are located shall have the
5.11 power and authority to reconstruct and repair the bridge upon giving notice to the town
5.12 board of the town or towns of its intention to do so and fixing a time and place for a
5.13 hearing as to the necessity and advisability of the reconstruction or repair.

5.14 (c) If a load rating analysis is required and has not been performed within 90 days of
5.15 the date the report required in section 165.03, subdivision 3, was delivered to the town,
5.16 the county is authorized to perform the analysis. Before it performs an analysis on a
5.17 town bridge, the county shall notify the town or towns that if the town or towns do not
5.18 perform the analysis within 90 days the county will perform the analysis and bill the
5.19 town or towns for all related expenses. If the town performs the analysis, a copy shall
5.20 be provided to the county engineer. If the county performs the analysis, a copy shall be
5.21 provided to the town clerk.

5.22 (d) If a load rating analysis determines a new or different load posting is required on
5.23 a town bridge, the town or towns charged with the duty of maintaining the bridge shall
5.24 provide the required posting within 30 days. If the town or towns fail to provide the
5.25 required posting, the county is authorized to provide the required posting. Before posting
5.26 a load limit on a town bridge, the county shall notify the town or towns that if the town
5.27 or towns do not provide the posting within 30 days the county will provide the required
5.28 posting and bill the town or towns for all related expenses, unless the town or towns and
5.29 the county agree to post the bridge in less than 30 days and at an agreed-upon cost.

5.30 (e) If a bridge constitutes a critical risk to public safety because its deficiencies, if
5.31 not immediately corrected, could result in collapse or partial collapse, the county engineer
5.32 is authorized to immediately close the bridge. The bridge shall remain closed until the
5.33 necessary steps are taken to remove the threat of collapse or partial collapse, or until a
5.34 subsequent inspection determines the issues resulting in closure are resolved. The county
5.35 may bill the town or towns for all related expenses.

6.1 (f) A county is not liable for a town's or towns' failure to act as required by this
6.2 section or section 165.03.

6.3 Sec. 10. Minnesota Statutes 2013 Supplement, section 169.19, subdivision 1, is
6.4 amended to read:

6.5 Subdivision 1. **Turning at intersection.** The driver of a vehicle intending to turn
6.6 at an intersection shall do so as follows:

6.7 (a) Except as otherwise provided in this paragraph, both the approach for a right turn
6.8 and a right turn shall be made as close as practicable to the right-hand curb or edge of the
6.9 roadway. When necessary to accommodate vehicle configuration, a driver is permitted to
6.10 make a right turn into the farthest lane of a roadway with two or more lanes in the same
6.11 direction in order to make a U-turn at a reduced conflict intersection, if it is safe to do so.

6.12 (b) Approach for a left turn on other than one-way roadways shall be made in that
6.13 portion of the right half of the roadway nearest the centerline thereof, and after entering
6.14 the intersection the left turn shall be made so as to leave the intersection to the right of the
6.15 centerline of the roadway being entered. Whenever practicable the left turn shall be made
6.16 in that portion of the intersection to the left of the center of the intersection.

6.17 (c) Approach for a left turn from a two-way roadway into a one-way roadway shall
6.18 be made in that portion of the right half of the roadway nearest the centerline thereof and
6.19 by passing to the right of such centerline where it enters the intersection.

6.20 (d) A left turn from a one-way roadway into a two-way roadway shall be made
6.21 from the left-hand lane and by passing to the right of the centerline of the roadway being
6.22 entered upon leaving the intersection.

6.23 (e) Where both streets or roadways are one way, both the approach for a left turn and
6.24 a left turn shall be made as close as practicable to the left-hand curb or edge of the roadway.

6.25 (f) Local authorities in their respective jurisdictions may cause markers, buttons, or
6.26 signs to be placed within or adjacent to intersections and thereby require and direct that a
6.27 different course from that specified in this section be traveled by vehicles turning at an
6.28 intersection, and when markers, buttons, or signs are so placed no driver of a vehicle shall
6.29 turn a vehicle at an intersection other than as directed and required by such markers,
6.30 buttons, or signs.

6.31 (g) Whenever it is necessary for the driver of a motor vehicle to cross a bicycle
6.32 lane adjacent to the driver's lane of travel to make a turn, the driver shall first signal the
6.33 movement, then drive the motor vehicle into the bicycle lane prior to making the turn,
6.34 but only after it is safe to do so. The driver shall then make the turn consistent with any

7.1 traffic markers, buttons, or signs, yielding the right-of-way to any vehicles or bicycles
7.2 approaching so close thereto as to constitute an immediate hazard.

7.3 Sec. 11. Minnesota Statutes 2012, section 169.19, subdivision 2, is amended to read:

7.4 Subd. 2. **U-turn.** No vehicle shall be turned so as to proceed in the opposite
7.5 direction upon any curve, or upon the approach to or near the crest of a grade, where
7.6 ~~such~~ the vehicle cannot be seen by the driver of any other vehicle approaching from
7.7 either direction within 1,000 feet, nor shall the driver of a vehicle turn the vehicle so as to
7.8 proceed in the opposite direction unless the movement can be made safely and without
7.9 interfering with other traffic. When necessary to accommodate vehicle configuration on a
7.10 roadway with two or more lanes in the same direction, a driver may turn the vehicle into
7.11 the farthest lane and temporarily use the shoulder to make a U-turn.

7.12 Sec. 12. Minnesota Statutes 2012, section 169.771, subdivision 2, is amended to read:

7.13 Subd. 2. **Inspection by state trooper.** (a) The commissioner of public safety is
7.14 directed to accelerate spot-check inspections for unsafe motor vehicles and motor vehicle
7.15 equipment. Such inspections shall be conducted by the personnel of the State Patrol who
7.16 shall give the operator of a commercial motor vehicle a signed and dated document as
7.17 evidence of the inspection.

7.18 (b) However, personnel of the State Patrol may not conduct another spot inspection
7.19 of a commercial motor vehicle if (1) the operator of the vehicle can show evidence of an
7.20 inspection, which is free of critical defects, conducted in Minnesota according to this
7.21 section or section 169.781 within the previous 90 days and (2) a state trooper does not
7.22 have probable cause to believe the vehicle or its equipment is unsafe or that the operator
7.23 has engaged in illegal activity. In addition, if the operator shows the state trooper evidence
7.24 that the commercial motor vehicle has been inspected within the previous 90 days, but the
7.25 officer has probable cause to believe the vehicle or its equipment is unsafe or to suspect
7.26 illegal activity, then the vehicle may be inspected to confirm the existence or absence of an
7.27 unsafe condition or of the suspected illegal activity.

7.28 (c) A vehicle stopped under this section and determined to be a covered farm
7.29 vehicle as defined in Code of Federal Regulations, title 49, section 390.5, and not carrying
7.30 hazardous materials of a type or quantity that requires the vehicle to be placarded in
7.31 accordance with Code of Federal Regulations, title 49, section 172.504, is exempt from
7.32 further inspection under this section. If probable cause exists to believe the vehicle or its
7.33 equipment is unsafe or illegal activity is suspected, enforcement action may be initiated.

8.1 Sec. 13. Minnesota Statutes 2012, section 169.781, subdivision 10, is amended to read:

8.2 Subd. 10. **Exemption Exemptions.** (a) This section does not apply to a vehicle
8.3 operated by a motor carrier of passengers, as defined in section 221.012, subdivision 26,
8.4 if the vehicle has been inspected under section 221.0252, subdivision 3, paragraph (a),
8.5 clause (2), within the previous 12 months.

8.6 (b) This section does not apply to a covered farm vehicle, as defined in Code of
8.7 Federal Regulations, title 49, section 390.5, that is not carrying hazardous materials of
8.8 a type or quantity that requires the vehicle to be placarded in accordance with Code of
8.9 Federal Regulations, title 49, section 172.504.

8.10 Sec. 14. Minnesota Statutes 2012, section 169.782, subdivision 4, is amended to read:

8.11 Subd. 4. **Exceptions.** (a) With the exception of subdivision 2, paragraph (a), clause
8.12 (2), this section does not apply to a commercial motor vehicle that is a farm truck that may
8.13 be operated by a person not holding a commercial driver's license.

8.14 (b) This section does not apply to a commercial motor vehicle held for resale by a
8.15 motor vehicle dealer licensed under section 168.27.

8.16 (c) This section does not apply to a covered farm vehicle as defined in Code of
8.17 Federal Regulations, title 49, section 390.5, that is not carrying hazardous materials of
8.18 a type or quantity that requires the vehicle to be placarded in accordance with Code of
8.19 Federal Regulations, title 49, section 172.504.

8.20 Sec. 15. Minnesota Statutes 2012, section 169.865, subdivision 2, is amended to read:

8.21 Subd. 2. **Seven-axle vehicles.** (a) A road authority may issue an annual permit
8.22 authorizing a vehicle or combination of vehicles with a total of seven or more axles to
8.23 haul raw or unprocessed agricultural products and be operated with a gross vehicle weight
8.24 of up to:

8.25 (1) 97,000 pounds; and

8.26 (2) 99,000 pounds during the period set by the commissioner under section 169.826,
8.27 subdivision 1.

8.28 (b) Drivers of vehicles operating under this subdivision must comply with driver
8.29 qualification requirements adopted under section 221.0314, subdivisions 2 to 5, and Code
8.30 of Federal Regulations, title 49, parts 40 and 382, unless exempt under section 221.031,
8.31 subdivision 2c.

8.32 (c) The fee for a permit issued under this subdivision is \$500.

8.33 Sec. 16. Minnesota Statutes 2012, section 171.02, subdivision 2, is amended to read:

9.1 Subd. 2. **Driver's license classifications, endorsements, exemptions.** (a) Drivers'
9.2 licenses are classified according to the types of vehicles that may be driven by the holder
9.3 of each type or class of license. The commissioner may, as appropriate, subdivide the
9.4 classes listed in this subdivision and issue licenses classified accordingly.

9.5 (b) Except as provided in paragraph (c), clauses (1) and (2), and subdivision 2a, no
9.6 class of license is valid to operate a motorcycle, school bus, tank vehicle, double-trailer
9.7 or triple-trailer combination, vehicle transporting hazardous materials, or bus, unless
9.8 so endorsed. There are four general classes of licenses as described in paragraphs (c)
9.9 through (f).

9.10 (c) Class D drivers' licenses are valid for:

9.11 (1) operating all farm trucks if the farm truck is:

9.15 including hazardous materials, to or from a farm;

9.16 (iii) not used in the operations of a common or contract motor carrier as governed by
9.17 Code of Federal Regulations, title 49, part 365; and

9.18 (iv) used within 150 miles of the farm;

9.19 (2) notwithstanding paragraph (b), operating an authorized emergency vehicle, as
9.20 defined in section 169.011, subdivision 3, whether or not in excess of 26,000 pounds
9.21 gross vehicle weight;

9.22 (3) operating a recreational vehicle as defined in section 168.002, subdivision 27,
9.23 that is operated for personal use;

9.24 (4) operating all single-unit vehicles except vehicles with a gross vehicle weight of
9.25 more than 26,000 pounds, vehicles designed to carry more than 15 passengers including
9.26 the driver, and vehicles that carry hazardous materials;

9.27 (5) notwithstanding paragraph (d), operating a type A school bus or a multifunction
9.28 school activity bus without a school bus endorsement if the requirements of subdivision 2a
9.29 are satisfied, as determined by the commissioner;

9.30 (6) operating any vehicle or combination of vehicles when operated by a licensed
9.31 peace officer while on duty; ~~and~~

9.32 (7) towing vehicles if:

9.33 (i) the towed vehicles have a gross vehicle weight of 10,000 pounds or less; or

9.34 (ii) the towed vehicles have a gross vehicle weight of more than 10,000 pounds and
9.35 the combination of vehicles has a gross vehicle weight of 26,000 pounds or less; and

10.1 (8) operating a covered farm vehicle as defined in Code of Federal Regulations,
10.2 title 49, section 390.5, that is not carrying hazardous materials of a type or quantity that
10.3 requires the vehicle to be placarded in accordance with Code of Federal Regulations,
10.4 title 49, section 172.504.

10.5 (d) Class C drivers' licenses are valid for:

10.6 (1) operating class D motor vehicles;

10.7 (2) with a hazardous materials endorsement, operating class D vehicles to transport
10.8 hazardous materials;

10.9 (3) with a passenger endorsement, operating buses; and

10.10 (4) with a passenger endorsement and school bus endorsement, operating school
10.11 buses.

10.12 (e) Class B drivers' licenses are valid for:

10.13 (1) operating all class C motor vehicles, class D motor vehicles, and all other
10.14 single-unit motor vehicles including, with a passenger endorsement, buses; and

10.15 (2) towing only vehicles with a gross vehicle weight of 10,000 pounds or less.

10.16 (f) Class A drivers' licenses are valid for operating any vehicle or combination of
10.17 vehicles.

10.18 Sec. 17. Minnesota Statutes 2012, section 171.03, is amended to read:

10.19 **171.03 PERSONS EXEMPT.**

10.20 The following persons are exempt from license hereunder:

10.21 (a) A person in the employ or service of the United States federal government is
10.22 exempt while driving or operating a motor vehicle owned by or leased to the United
10.23 States federal government.

10.24 (b) A person in the employ or service of the United States federal government is
10.25 exempt from the requirement to possess a valid class A, class B, or class C commercial

Subd. 240. **Route No. 309.** Beginning at a point on Route No. 18 at or near Brainerd, thence extending in a general northwesterly direction to a point at or in the grounds of the Brainerd State School and Hospital, thence extending in a general southerly direction to a point on Route No. 18 at or near Brainerd.

221.0314 FEDERAL SAFETY REGULATIONS; ADOPTION.

Subd. 9a. **Hours of service exemptions.** The federal regulations incorporated in subdivision 9 for maximum driving and on-duty time do not apply to drivers engaged in the interstate or intrastate transportation of:

(1) agricultural commodities or farm supplies for agricultural purposes in Minnesota during the planting and harvesting seasons from March 15 to December 15 of each year; or

(2) sugar beets during the harvesting season for sugar beets from September 1 to May 15 of each year;

if the transportation is limited to an area within a 150-air-mile radius from the source of the commodities or from the retail or wholesale distribution point of the farm supplies.
