1.5 Section 1. **LEGISLATIVE ROUTE NO. 227 REMOVED.**

1.6 (a) Minnesota Statutes, section 161.115, subdivision 158, is repealed effective the  
1.7 day after the commissioner of transportation receives a copy of the agreement between  
1.8 the commissioner and the governing body of Wadena County to transfer jurisdiction of  
1.9 Legislative Route No. 227 and notifies the revisor of statutes under paragraph (b).

1.10 (b) The revisor of statutes shall delete the route identified in paragraph (a) from  
1.11 Minnesota Statutes when the commissioner of transportation sends notice to the revisor  
1.12 electronically or in writing that the conditions required to transfer the route have been  
1.13 satisfied.
