1.7	Laws 2015, First Special Session chapter 5, article 3, section 23, is amended to read:
1.8 1.9	Subd. 23. Virginia - Highway 53 Utilities Relocation 19,500,000
1.10	(a) \$500,000 of this appropriation is for a grant
1.11	to the city of Virginia Public Utilities
1.12	Commission to acquire land, predesign,
1.13	design, construct, furnish, and equip an
1.14	electrical substation along or within six miles
1.15	of the relocated U.S. Highway 53 in Virginia
1.16	as part of relocating the electrical utilities. This
1.17	appropriation fully funds the project described
1.18	in this paragraph and meets the requirements
