1.1 A bill for an act
1.2 relating to animal health; modifying requirements for certain owners of farmed
1.3 Cervidae; requiring live-animal testing for chronic wasting disease; transferring
1.4 certain duties from the Board of Animal Health to the commissioner of natural
1.5 resources; appropriating money; amending Minnesota Statutes 2020, section
1.6 35.155, subdivisions 1, 4, 6, 10, by adding a subdivision; Minnesota Statutes 2021
1.7 Supplement, section 35.155, subdivision 11.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2020, section 35.155, subdivision 1, is amended to read:

1.10 Subdivision 1. **Running at large prohibited.** (a) An owner may not allow farmed
1.11 Cervidae to run at large. The owner must make all reasonable efforts to return escaped
1.12 farmed Cervidae to their enclosures as soon as possible. The owner must immediately notify
1.13 the commissioner of natural resources of the escape of farmed Cervidae if the farmed
1.14 Cervidae are not returned or captured by the owner within 24 hours of their escape.

1.15 (b) An owner is liable for expenses of another person in capturing, caring for, and
1.16 returning farmed Cervidae that have left their enclosures if the person capturing the farmed
1.17 Cervidae contacts the owner as soon as possible.

1.18 (c) If an owner is unwilling or unable to capture escaped farmed Cervidae, the
1.19 commissioner of natural resources may destroy the escaped farmed Cervidae. The
1.20 commissioner of natural resources must allow the owner to attempt to capture the escaped
1.21 farmed Cervidae prior to destroying the farmed Cervidae. Farmed Cervidae that are not
1.22 captured by 24 hours after escape may be destroyed.

2.1 (d) A hunter licensed by the commissioner of natural resources under chapter 97A may
2.2 kill and possess escaped farmed Cervidae in a lawful manner and is not liable to the owner
2.3 for the loss of the animal.

2.4 (e) Escaped farmed Cervidae killed by a hunter or destroyed by the commissioner of
2.5 natural resources must be tested for chronic wasting disease at the owner's expense.

2.6 **EFFECTIVE DATE.** This section is effective September 1, 2022.

2.7 Sec. 2. Minnesota Statutes 2020, section 35.155, subdivision 4, is amended to read:

2.8 Subd. 4. **Fencing.** Farmed Cervidae must be confined in a manner designed to prevent
2.9 escape. Except as provided in subdivision 4a, all perimeter fences for farmed Cervidae must
2.10 be at least 96 inches in height and be constructed and maintained in a way that prevents the
2.11 escape of farmed Cervidae or, entry into the premises by free-roaming Cervidae, and physical
2.12 contact between farmed Cervidae and free-roaming Cervidae. After July 1, 2019, All new
2.13 fencing installed and all fencing used to repair deficiencies must be high tensile. By
2.14 December 1, 2019, All entry areas for farmed Cervidae enclosure areas must have two
2.15 redundant gates, which must be maintained to prevent the escape of animals through an
2.16 open gate. If a fence deficiency allows entry or exit by farmed or wild Cervidae, the owner
2.17 must repair the deficiency within a reasonable time, as determined by the Board of Animal
2.18 Health, not to exceed 45 days. If a fence deficiency is detected during an inspection, the
2.19 facility must be reinspected at least once in the subsequent three months. The farmed
2.20 Cervidae owner must pay a reinspection fee equal to one-half the applicable annual inspection
2.21 fee under subdivision 7a for each reinspection related to a fence violation. If the facility
2.22 experiences more than one escape incident in any six-month period or fails to correct a
2.23 deficiency found during an inspection, the board may revoke the facility's registration and
2.24 order the owner to remove or destroy the animals as directed by the board. If the board
2.25 revokes a facility's registration, the commissioner of natural resources may seize and destroy
2.26 animals at the facility.

2.27 **EFFECTIVE DATE.** This section is effective September 1, 2023.

2.28 Sec. 3. Minnesota Statutes 2020, section 35.155, is amended by adding a subdivision to
2.29 read:

2.30 Subd. 4a. **Fencing; commercial herds.** In addition to the requirements in subdivision
2.31 4, commercially farmed white-tailed deer must be confined by two or more perimeter fences,
2.32 with each perimeter fence at least 120 inches in height.

3.1 **EFFECTIVE DATE.** This section is effective September 1, 2023.

3.2 Sec. 4. Minnesota Statutes 2020, section 35.155, subdivision 6, is amended to read:

3.3 Subd. 6. **Identification.** (a) Farmed Cervidae must be identified by means approved by
3.4 the Board of Animal Health. The identification must include a distinct number that has not
3.5 been used during the previous three years and must be visible to the naked eye during
3.6 daylight under normal conditions at a distance of 50 yards. The identification for white-tailed
3.7 deer must also include contact information with a phone number or address that enables the
3.8 reader to readily identify the owner of escaped deer. This contact information does not need
3.9 to be visible from a distance of 50 yards. White-tailed deer must be identified before October
3.10 31 of the year in which the animal is born, at the time of weaning, or before movement from
3.11 the premises, whichever occurs first. Elk and other cervids must be identified by December
3.12 31 of the year in which the animal is born or before movement from the premises, whichever
3.13 occurs first. As coordinated by the board, the commissioner of natural resources may destroy
3.14 any animal that is not identified as required under this subdivision.

3.15 (b) The Board of Animal Health shall register farmed Cervidae. The owner must submit
3.16 the registration request on forms provided by the board. The forms must include sales
3.17 receipts or other documentation of the origin of the Cervidae. The board must provide copies
3.18 of the registration information to the commissioner of natural resources upon request. The
3.19 owner must keep written records of the acquisition and disposition of registered farmed
3.20 Cervidae.

3.21 **EFFECTIVE DATE.** This section is effective September 1, 2023.

3.22 Sec. 5. Minnesota Statutes 2020, section 35.155, subdivision 10, is amended to read:

3.23 Subd. 10. **Mandatory registration.** (a) A person may not possess live Cervidae in
3.24 Minnesota unless the person is registered with the Board of Animal Health and meets all
3.25 the requirements for farmed Cervidae under this section. Cervidae possessed in violation
3.26 of this subdivision may be seized and destroyed by the commissioner of natural resources.

3.27 (b) A person whose registration is revoked by the board is ineligible for future registration
3.28 under this section unless the board determines that the person has undertaken measures that
3.29 make future escapes extremely unlikely.

3.30 (c) The board must not allow new registrations under this section for possessing
3.31 white-tailed deer.

3.32 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.1 Sec. 6. Minnesota Statutes 2021 Supplement, section 35.155, subdivision 11, is amended
4.2 to read:

4.3 Subd. 11. **Mandatory surveillance for chronic wasting disease; depopulation.** (a)

4.4 An inventory for each farmed Cervidae herd must be verified by an accredited veterinarian
4.5 and filed with the Board of Animal Health every 12 months.

4.6 (b) Movement of farmed Cervidae from any premises to another location must be reported
4.7 to the Board of Animal Health within 14 days of the movement on forms approved by the
4.8 Board of Animal Health. A person must not move farmed white-tailed deer from any premises
4.9 to another location.

4.10 (c) All animals from farmed Cervidae herds that are over 12 months of age that die or
4.11 are slaughtered must be tested for chronic wasting disease.

4.12 (d) The owner of a premises where chronic wasting disease is detected must:

4.13 (1) allow and cooperate with inspections of the premises as determined by the Board of
4.14 Animal Health and Department of Natural Resources conservation officers and wildlife
4.15 managers;

4.16 ~~(1)~~ (2) depopulate the premises of Cervidae after the federal indemnification process
4.17 has been completed or, if an indemnification application is not submitted, within a reasonable
4.18 time determined by the board in consultation with the commissioner of natural resources;

4.19 ~~(2)~~ (3) maintain the fencing required under ~~subdivision~~ subdivisions 4 and 4a on the
4.20 premises for ~~five~~ ten years after the date of detection; ~~and~~

4.21 ~~(3)~~ (4) post the fencing on the premises with biohazard signs as directed by the board;

4.22 (5) not raise farmed Cervidae on the premises for at least ten years;

4.23 (6) prior to any sale or transfer of the premises, test the soil for evidence of chronic
4.24 wasting disease using a method approved by the board and report the results to the board;
4.25 and

4.26 (7) record with the county recorder or registrar of titles a notice, in the form required by
4.27 the board, that includes the location and legal description of the premises, the date of
4.28 detection, the date of depopulation, the landowner requirements under this paragraph, and
4.29 any other information required by the board.

4.30 (e) The Board of Animal Health must treat a state with chronic wasting disease in its
4.31 wild Cervidae or farmed Cervidae populations as a chronic wasting disease endemic area.

5.1 Sec. 7. **WHITE-TAILED DEER TESTING REQUIRED; CHRONIC WASTING**
5.2 **DISEASE.**

5.3 Subdivision 1. **Live-animal testing.** No later than October 1, 2022, an owner of farmed
5.4 white-tailed deer registered with the Board of Animal Health under Minnesota Statutes,
5.5 section 35.155, must have each farmed white-tailed deer tested for chronic wasting disease
5.6 using a real-time quaking-induced conversion (RT-QuIC) test and report the results to the
5.7 Board of Animal Health in the form required by the board. If a white-tailed deer tests
5.8 positive, the owner must have the animal tested a second time using an RT-QuIC test.

5.9 Subd. 2. **Postmortem testing.** If a farmed white-tailed deer tests positive twice under
5.10 subdivision 1, the owner must have the animal destroyed and tested for chronic wasting
5.11 disease using a postmortem test approved by the Board of Animal Health.

5.12 Subd. 3. **Herd depopulation.** If a farmed white-tailed deer tests positive for chronic
5.13 wasting disease under subdivision 2, the owner must depopulate the premises of farmed
5.14 Cervidae as required under Minnesota Statutes, section 35.155.

5.15 Sec. 8. **TRANSFER OF DUTIES; FARMED CERVIDAE.**

5.16 (a) Except as provided in paragraph (b), the responsibilities for administering and
5.17 enforcing the statutes and rules listed in clauses (1) and (2) are transferred pursuant to
5.18 Minnesota Statutes, section 15.039, from the Board of Animal Health to the commissioner
5.19 of natural resources:

5.20 (1) Minnesota Statutes, sections 35.153 and 35.155; and

5.21 (2) Minnesota Rules, parts 1721.0370 to 1721.0420.

5.22 (b) Notwithstanding Minnesota Statutes, section 15.039, subdivision 7, the transfer of
5.23 personnel will not take place. The commissioner of natural resources must contract with
5.24 the Board of Animal Health for any veterinary services required to administer this program.

5.25 **EFFECTIVE DATE.** This section is effective July 1, 2024.

5.26 Sec. 9. **APPROPRIATION.**

5.27 \$250,000 in fiscal year 2023 is appropriated from the general fund to the Board of Animal
5.28 Health for purposes of section 7. The board must issue a request for proposal for the RT-QuIC
5.29 testing required. This is a onetime appropriation.

6.1 Sec. 10. **REVISOR INSTRUCTION.**

6.2 The revisor of statutes must recodify the relevant sections in Minnesota Statutes, chapter
6.3 35, and Minnesota Rules, chapter 1721, as necessary to conform with section 8. The revisor
6.4 must also change the responsible agency, remove obsolete language, and make necessary
6.5 cross-reference changes consistent with section 8 and the renumbering.
