BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **INVER HILLS COMMUNITY COLLEGE.**
- 1.6

Subdivision 1. **Appropriation.** \$14,653,000 is appropriated from the bond proceeds
- 1.7

fund to the Board of Trustees of the Minnesota State Colleges and Universities to design,
- 1.8

renovate, and equip the Technology and Business Center building, including the construction
- 1.9

of a link to Heritage Hall at Inver Hills Community College.
- 1.10

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
- 1.11

proceeds fund, the commissioner of management and budget shall sell and issue bonds of
- 1.12

the state in an amount up to \$14,653,000 in the manner, upon the terms, and with the effect
- 1.13

prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota

Constitution, article XI, sections 4 to 7.
