1.8	(a) If parties have agreed to conduct transactions by electronic means and a law
1.9	requires a person to provide, send, or deliver information in writing to another person, the
1.10	requirement is satisfied if the information is provided, sent, or delivered, as the case may
1.11	be, in an electronic record capable of retention by the recipient at the time of receipt. An
1.12	electronic record is not capable of retention by the recipient if the sender or its information
1.13	processing system inhibits the ability of the recipient to print or store the electronic record.
1.14	(b) If a law other than this chapter requires a record (i) to be posted or displayed in a
1.15	certain manner, (ii) to be sent, communicated, or transmitted by a specified method, or (iii)
