1.7	fund to the Board of Trustees of the Minnesota State Colleges and Universities to construct
1.8	renovate, furnish, and equip Eastman Hall for the relocation of consolidated student health

1.10	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
