1.1 A bill for an act
1.2 relating to education; modifying lead testing and remediation requirements in
1.3 schools; requiring a report; appropriating money; amending Minnesota Statutes
1.4 2022, sections 121A.335; 123B.595, subdivisions 1, 2, 7, 8, 8a, 9.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2022, section 121A.335, is amended to read:

1.7 121A.335 LEAD IN SCHOOL DRINKING WATER.

1.8 Subdivision 1. Model plan. The commissioners of health and education shall jointly
1.9 develop a model plan to require school districts to accurately and efficiently test for the
1.10 presence of lead in water in public school buildings serving students in kindergarten through
1.11 grade 12. To the extent possible, the commissioners shall base the plan on the standards
1.12 established by the United States Environmental Protection Agency. The plan may be based
1.13 on the technical guidance in the Department of Health's document, "Reducing Lead in
1.14 Drinking Water: A Technical Guidance for Minnesota's School and Child Care Facilities."
1.15 The plan must include recommendations for remediation efforts when testing reveals the
1.16 presence of lead above five parts per billion.

1.17 Subd. 2. School plans. By July 1, 2018, the board of each school district or charter
1.18 school must adopt the commissioners' model plan or develop and adopt an alternative plan
1.19 to accurately and efficiently test for the presence of lead in water in school buildings serving
1.20 prekindergarten students and students in kindergarten through grade 12.

1.21 Subd. 3. Frequency of testing. (a) The plan under subdivision 2 must include a testing
1.22 schedule for every building serving prekindergarten through grade 12 students. The schedule
1.23 must require that each building be tested at least once every five years. A school district or

2.1 charter school must begin testing school buildings by July 1, 2018, and complete testing of  
2.2 all buildings that serve students within five years.

2.3 (b) A school district or charter school that finds lead at a specific location providing  
2.4 cooking or drinking water within a facility must formulate, make publicly available, and  
2.5 implement a plan that is consistent with established guidelines and recommendations to  
2.6 ensure that student exposure to lead is minimized. This includes, when a school district or  
2.7 charter school finds the presence of lead ~~at a level where action should be taken as set by~~  
2.8 ~~the guidance~~ above five parts per billion in any water source that can provide cooking or  
2.9 drinking water, immediately shutting off the water source or making it unavailable until the  
2.10 hazard has been minimized.

2.11 (c) A school district or charter school must test for the presence of lead after completing  
2.12 remediation activities required under this section to confirm that the water contains lead at  
2.13 a level less than five parts per billion.

2.14 Subd. 4. **Ten-year facilities plan.** A school district ~~may~~ must include lead testing and  
2.15 remediation as a part of its ten-year facilities plan under section 123B.595.

2.16 Subd. 5. **Reporting.** (a) ~~A school district or charter school that has tested its buildings~~  
2.17 ~~for the presence of lead shall make the results of the testing available to the public for review~~  
2.18 ~~and must notify parents of the availability of the information.~~ must send parents an annual  
2.19 notice that includes the district's or charter school's annual testing and remediation plan,  
2.20 information about how to find test results, and a description of remediation efforts on the  
2.21 district website. The district or charter school must update the lead testing and remediation  
2.22 information on its website at least annually. In addition to the annual notice, the district or  
2.23 charter school must include in an official school handbook or official school policy guide  
2.24 information on how parents may find the test results and a description of remediation efforts  
2.25 on the district or charter school website and how often this information is updated.

2.26 (b) School districts and charter schools must follow the actions outlined in guidance  
2.27 from the commissioners of health and education. If a test conducted under subdivision 3,  
2.28 paragraph (a), reveals the presence of lead above a level where action should be taken as  
2.29 set by the guidance five parts per billion, the school district or charter school must, within  
2.30 30 days of receiving the test result, either remediate the presence of lead to below the level  
2.31 set in guidance, verified by retest, or directly notify parents of the test result. The school  
2.32 district or charter school must make the water source unavailable until the hazard has been  
2.33 minimized and remediation activities have been completed in accordance with subdivision  
2.34 3.

3.1 (c) School districts and charter schools must report their test results to the commissioner  
 3.2 of health in the form and manner determined by the commissioner. If a test reveals the  
 3.3 presence of lead above five parts per billion, the school district or charter school must also  
 3.4 report its remediation efforts. The commissioner of health must post, and annually update,  
 3.5 the test results and remediation efforts on the department website, by school site.

3.6 Subd. 6. **Public water system.** If testing reveals that a significant contributor to lead  
 3.7 contamination in school drinking water is the infrastructure operated by a public water  
 3.8 system that is not a school water system, the district or charter school is not financially  
 3.9 responsible for remediating elevated lead levels in drinking water that passes through that  
 3.10 infrastructure. The district or charter school must communicate with the public water system  
 3.11 regarding its documented significant contribution to lead contamination in school drinking  
 3.12 water and request from the public water system a plan for reducing the lead contamination.  
 3.13 The district or charter school may defer its remediation activities under this section until  
 3.14 after the elevated lead level in the public water system's infrastructure is remediated and  
 3.15 postremediation testing does not detect an elevated lead level in the drinking water that  
 3.16 passes through that infrastructure.

3.17 Subd. 7. **Commissioner recommendations.** By January 1, 2026, and every five years  
 3.18 thereafter, the commissioner of health must report to the legislative committees having  
 3.19 jurisdiction over health and kindergarten through grade 12 education any recommended  
 3.20 changes to this section, including whether to change the level of lead that requires  
 3.21 remediation. The recommendations must be based on currently available scientific evidence  
 3.22 regarding the effects of lead in drinking water.

3.23 **EFFECTIVE DATE.** This section is effective July 1, 2023.

7.9 (b) A Tribal contract or grant school that receives revenue under Minnesota Statutes,

7.12 at the school site. An applicant for a grant must submit to the commissioner a plan to test  
7.13 for lead or the results of any testing performed in the previous five years and a description
