\$5,250,000 is appropriated for the fiscal year ending June 30, 2020, to the commissioner
 of employment and economic development to establish and administer the grant program
 authorized under Minnesota Statutes, section 116J.998. The commissioner may use up to
 \$250,000 of this amount to contract with a vendor and for other administrative costs.
