1.10	sight to a person who obtains the required licenses and who has a permanent physical
1.11	disability that prohibits the person from raising the person's arms to shoulder height.
1.12	(b) The permanent physical disability must be established by medical evidence
1.13	verified in writing by a licensed physician, chiropractor, or certified nurse practitioner
1.14	or certified physician assistant acting under the direction of a licensed physician. The
