1.1 A bill for an act
1.2 relating to economic development; establishing a medical center development
1.3 authority and providing for its organization, powers, and duties; providing
1.4 for medical center development districts; authorizing the issuance of revenue
1.5 obligations by the authority; authorizing city bonds; authorizing state assistance;
1.6 providing for tax increment financing within a medical center development
1.7 district; appropriating money; amending Minnesota Statutes 2012, sections
1.8 272.02, subdivision 39; 469.174, subdivision 8; 469.176, subdivisions 1b, 4c;
1.9 proposing coding for new law in Minnesota Statutes, chapter 469.

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2012, section 272.02, subdivision 39, is amended to read:

1.12 Subd. 39. **Economic development; public purpose.** The holding of property by
1.13 a political subdivision of the state for later resale for economic development purposes,
1.14 including property held as part of a destination medical center project described in
1.15 section 469.41, subdivision 11, shall be considered a public purpose in accordance with
1.16 subdivision 8 for a period not to exceed nine years, except that for property located in a
1.17 city of 5,000 population or under that is located outside of the metropolitan area as defined
1.18 in section 473.121, subdivision 2, the period must not exceed 15 years.

1.19 The holding of property by a political subdivision of the state for later resale (1)
1.20 which is purchased or held for housing purposes, or (2) which meets the conditions
1.21 described in section 469.174, subdivision 10, shall be considered a public purpose in
1.22 accordance with subdivision 8.

1.23 The governing body of the political subdivision which acquires property which is
1.24 subject to this subdivision shall after the purchase of the property certify to the city or
1.25 county assessor whether the property is held for economic development purposes or
1.26 housing purposes, or whether it meets the conditions of section 469.174, subdivision 10.

2.1 If the property is acquired for economic development purposes and buildings or other
 2.2 improvements are constructed after acquisition of the property, and if more than one-half
 2.3 of the floor space of the buildings or improvements which is available for lease to or use
 2.4 by a private individual, corporation, or other entity is leased to or otherwise used by
 2.5 a private individual, corporation, or other entity the provisions of this subdivision shall
 2.6 not apply to the property. This subdivision shall not create an exemption from section
 2.7 272.01, subdivision 2; 272.68; 273.19; or 469.040, subdivision 3; or other provision of
 2.8 law providing for the taxation of or for payments in lieu of taxes for publicly held property
 2.9 which is leased, loaned, or otherwise made available and used by a private person.

2.10 Sec. 2. Minnesota Statutes 2012, section 469.174, subdivision 8, is amended to read:

2.11 Subd. 8. **Project.** "Project" means a project as described in section 469.142; an
 2.12 industrial development district as described in section 469.058, subdivision 1; an economic
 2.13 development district as described in section 469.101, subdivision 1; a project as defined
 2.14 in section 469.002, subdivision 12; a development district as defined in section 469.125,
 2.15 subdivision 9, or any special law; ~~or~~ a project as defined in section 469.153, subdivision 2,
 2.16 paragraph (a), (b), or (c), or a project as defined in section 469.41, subdivision 11.

2.17 Sec. 3. Minnesota Statutes 2012, section 469.176, subdivision 1b, is amended to read:

2.18 Subd. 1b. **Duration limits; terms.** (a) No tax increment shall in any event be
 2.19 paid to the authority:

2.20 (1) after 15 years after receipt by the authority of the first increment for a renewal
 2.21 and renovation district;

2.22 (2) after 20 years after receipt by the authority of the first increment for a soils
 2.23 condition district;

2.24 (3) after eight years after receipt by the authority of the first increment for an
 2.25 economic development district or, for an economic development district within a medical
 2.26 center development district created under section 469.48, subdivision 4, (i) after 15 years
 2.27 after receipt by the authority of the first increment for a residential rental/owner-occupied
 2.28 housing subdistrict, (ii) after 15 years after receipt by the authority of the first increment
 2.29 for a medical/healthcare industry subdistrict, or (iii) after ten years after receipt by the
 2.30 authority of the first increment for a commercial/industrial/retail subdistrict;

2.31 (4) for a housing district, a compact development district, or a redevelopment
 2.32 district, after 25 years from the date of receipt by the authority of the first increment.

2.33 (b) For purposes of determining a duration limit under this subdivision or subdivision
 2.34 1e that is based on the receipt of an increment, any increments from taxes payable in the year

3.1 in which the district terminates shall be paid to the authority. This paragraph does not affect
 3.2 a duration limit calculated from the date of approval of the tax increment financing plan or
 3.3 based on the recovery of costs or to a duration limit under subdivision 1c. This paragraph
 3.4 does not supersede the restrictions on payment of delinquent taxes in subdivision 1f.

3.5 (c) An action by the authority to waive or decline to accept an increment has no
 3.6 effect for purposes of computing a duration limit based on the receipt of increment under
 3.7 this subdivision or any other provision of law. The authority is deemed to have received an
 3.8 increment for any year in which it waived or declined to accept an increment, regardless
 3.9 of whether the increment was paid to the authority.

3.10 (d) Receipt by a hazardous substance subdistrict of an increment as a result of a
 3.11 reduction in original net tax capacity under section 469.174, subdivision 7, paragraph
 3.12 (b), does not constitute receipt of increment by the overlying district for the purpose of
 3.13 calculating the duration limit under this section.

3.14 Sec. 4. Minnesota Statutes 2012, section 469.176, subdivision 4c, is amended to read:

3.15 Subd. 4c. **Economic development districts.** (a) Revenue derived from tax increment
 3.16 from an economic development district may not be used to provide improvements, loans,
 3.17 subsidies, grants, interest rate subsidies, or assistance in any form to developments
 3.18 consisting of buildings and ancillary facilities, if more than 15 percent of the buildings and
 3.19 facilities (determined on the basis of square footage) are used for a purpose other than:

3.20 (1) the manufacturing or production of tangible personal property, including
 3.21 processing resulting in the change in condition of the property;

3.22 (2) warehousing, storage, and distribution of tangible personal property, excluding
 3.23 retail sales;

3.24 (3) with the consent of the Rochester Area Medical Center Development Authority
 3.25 and within a subdistrict of a medical center development district created under section
 3.26 469.48, subdivision 4, (i) residential rental or owner-occupied housing, (ii) the
 3.27 provision of medical or healthcare industry related services or products, or (iii) other
 3.28 commercial/industrial development and retail sales;

3.29 ~~(3)~~ (4) research and development related to the activities listed in clause (1) ~~or~~
 3.30 (2), or (3);

3.31 ~~(4)~~ (5) telemarketing if that activity is the exclusive use of the property;

3.32 ~~(5)~~ (6) tourism facilities;

3.33 ~~(6)~~ (7) qualified border retail facilities; or

3.34 ~~(7)~~ (8) space necessary for and related to the activities listed in clauses (1) to ~~(6)~~ (7).

4.1 (b) Notwithstanding the provisions of this subdivision, revenues derived from tax
4.2 increment from an economic development district may be used to provide improvements,
4.3 loans, subsidies, grants, interest rate subsidies, or assistance in any form for up to 15,000
4.4 square feet of any separately owned commercial facility located within the municipal
4.5 jurisdiction of a small city, if the revenues derived from increments are spent only to
4.6 assist the facility directly or for administrative expenses, the assistance is necessary to
4.7 develop the facility, and all of the increments, except those for administrative expenses,
4.8 are spent only for activities within the district.

4.9 (c) A city is a small city for purposes of this subdivision if the city was a small city
4.10 in the year in which the request for certification was made and applies for the rest of
4.11 the duration of the district, regardless of whether the city qualifies or ceases to qualify
4.12 as a small city.

4.13 (d) Notwithstanding the requirements of paragraph (a) and the finding requirements
4.14 of section 469.174, subdivision 12, tax increments from an economic development district
4.15 may be used to provide improvements, loans, subsidies, grants, interest rate subsidies, or
4.16 assistance in any form to developments consisting of buildings and ancillary facilities, if
4.17 all the following conditions are met:

4.18 (1) the municipality finds that the project will create or retain jobs in this state,
4.19 including construction jobs, and that construction of the project would not have
4.20 commenced before July 1, 2012, without the authority providing assistance under the
4.21 provisions of this paragraph;

4.22 (2) construction of the project begins no later than July 1, 2012;

4.23 (3) the request for certification of the district is made no later than June 30, 2012; and

4.24 (4) for development of housing under this paragraph, the construction must begin
4.25 before January 1, 2012.

4.26 The provisions of this paragraph may not be used to assist housing that is developed
4.27 to qualify under section 469.1761, subdivision 2 or 3, or similar requirements of other law,
4.28 if construction of the project begins later than July 1, 2011.

4.29 **Sec. 5. [469.40] PURPOSES.**

4.30 In order to secure Minnesota's status as one of the world's leading global medical
4.31 destinations now and in the future, with the city of Rochester as its hub, it is essential to
4.32 support state and local investment in the public infrastructure and related development
4.33 activities to stimulate significant private investment and development. Market forces are
4.34 driving a small number of select medical institutions to emerge worldwide as leaders in:
4.35 (1) delivering the highest quality medical care and attracting patients and visitors from

5.1 throughout the world; (2) conducting leading research and technology development; and
 5.2 (3) serving as an educational platform to foster development of clinical practitioners
 5.3 for the next generation of medical advancement. The city of Rochester is, and intends
 5.4 to continue to be, one of those leading destination medical centers. Its existing medical
 5.5 institutions must continue to make strategic capital investments to grow their patient base
 5.6 and deliver the highest quality care in the world. The city must attract new, medically
 5.7 related and other businesses as a means of major economic development and job growth
 5.8 in the state of Minnesota. However, continued success in Minnesota of existing medical
 5.9 institutions in Rochester is dependent upon the institutions' ability to attract leading
 5.10 clinicians, and sustain quality access, development, programming, services, and the public
 5.11 infrastructure necessary to meet the demands of a growing patient, visitor, and resident
 5.12 base. Investments in public infrastructure and related development activities are needed
 5.13 in order to support and attract significant private capital investments and the anticipated
 5.14 growth in patient and visitor traffic to Rochester and the surrounding area.

5.15 **Sec. 6. [469.41] DEFINITIONS.**

5.16 **Subdivision 1. Generally.** In sections 469.41 to 469.53, the terms defined in this
 5.17 section have the meanings given them, unless the context indicates a different meaning.

5.18 **Subd. 2. Authority.** "Authority" means the Rochester Area Medical Center
 5.19 Development Authority established in section 469.42.

5.20 **Subd. 3. City.** "City" means the city of Rochester, Minnesota.

5.21 **Subd. 4. County.** "County" means Olmsted County, Minnesota.

5.22 **Subd. 5. Designated state taxes.** "Designated state taxes" means as of any
 5.23 calculation date under section 469.53, subdivision 2, the following state taxes:

5.24 (1) personal income taxes payable under chapter 290 that are attributable to payroll
 5.25 for employees of all facilities in the city of any business entity located in the city and all
 5.26 facilities located in the state of any medical business entity;

5.27 (2) corporate franchise taxes paid under chapter 290 by businesses located in the
 5.28 city and by any medical business entity;

5.29 (3) commercial-industrial property taxes paid under section 275.025 by businesses
 5.30 located in the city and by any medical business entity; and

5.31 (4) sales taxes collected by businesses on retail sales within the city under sections
 5.32 297A.62 and 297A.63 and for all such taxes paid by any medical business entity.

5.33 **Subd. 6. Development; developing.** "Development" includes redevelopment,
 5.34 and "developing" includes redeveloping.

6.1 Subd. 7. **Development plan.** "Development plan" means the long-range plan for the
6.2 development of the medical center development district or districts.

6.3 Subd. 8. **Medical business entity.** "Medical business entity" means a medical
6.4 business entity with its principal place of business in the city of Rochester as of the date of
6.5 final enactment of this act that employs more than 30,000 persons in the state as of that date.

6.6 Subd. 9. **Medical center development district.** "Medical center development
6.7 district" means a contiguous or noncontiguous geographic area in the city created to
6.8 facilitate one or more projects.

6.9 Subd. 10. **Medical center economic development corporation.** "Medical center
6.10 economic development corporation" means a nonprofit corporation organized and existing
6.11 under chapter 317A by any medical business entity, in partnership with representatives of
6.12 the city experienced in matters of planning, supporting, and administering development
6.13 activities, to assist the authority and the city to secure Minnesota's status as one of the
6.14 world's leading global medical destinations with the city as its hub.

6.15 Subd. 11. **Project.** "Project" means the following works or undertakings for the
6.16 purpose of development of a medical center development district:

6.17 (1) to acquire real property and other assets associated with the real property;

6.18 (2) to demolish, repair, or rehabilitate buildings;

6.19 (3) to remediate land and buildings as required to prepare the property for acquisition
6.20 or development;

6.21 (4) to install, construct, or reconstruct elements of community infrastructure
6.22 required to support the overall development of the medical center development district,
6.23 including, without limitation, streets, roadways, utilities systems and related facilities,
6.24 utility relocations and replacements, network and communication systems, streetscape
6.25 improvements, drainage systems, sewer and water systems, subgrade structures and
6.26 associated improvements, landscaping, façade construction and restoration, wayfinding
6.27 and signage, and other components of community infrastructure;

6.28 (5) to acquire, construct or reconstruct, and equip parking facilities and other
6.29 facilities to encourage intermodal transportation and public transit;

6.30 (6) to install, construct or reconstruct, and equip core elements of community
6.31 infrastructure, to promote and encourage economic development and to anchor the medical
6.32 center developmental district in accordance with the development plan, including, without
6.33 limitation, parks, cultural facilities, community and recreational facilities, facilities to
6.34 promote tourism and hospitality, conferencing and conventions, broadcast and related
6.35 multimedia infrastructure, destination retail, urban residential housing, and instructional,

7.1 educational, and other facilities with the primary purpose of attracting and fostering urban
 7.2 economic development within the medical center development district;

7.3 (7) to make related site improvements, including, without limitation, excavation,
 7.4 earth retention, soil stabilization and correction, site improvements to support the medical
 7.5 center development district;

7.6 (8) to prepare land for private development and to sell or lease land; and

7.7 (9) to build and equip suitable structures on land owned by the authority for sale or
 7.8 lease for private development, except structures for sale or lease to a medical business
 7.9 entity.

7.10 Subd. 12. **Project cost.** (a) "Project cost" with respect to a medical center
 7.11 development district project means all costs of the project activities described in
 7.12 subdivision 11, and includes, without limitation:

7.13 (1) costs of planning, engineering, legal, marketing, development, insurance,
 7.14 finance, and other related professional services associated with a project;

7.15 (2) costs providing relocation benefits to the occupants of acquired properties;

7.16 (3) costs associated with the operational start-up and commissioning of a project; and

7.17 (4) the allocated administrative expenses of the authority for the project not to
 7.18 exceed in any year.

7.19 (b) Expenditures for project costs constitute either (1) public improvements to
 7.20 buildings or lands owned by the state or local government that serve a public purpose and
 7.21 do not principally benefit a single business or defined group of businesses at the time the
 7.22 improvements are made or (2) assistance generally available to all businesses or general
 7.23 classes of similar businesses within a medical center development district, subject to
 7.24 approval by the authority.

7.25 Sec. 7. **[469.42] AUTHORITY ESTABLISHED.**

7.26 Subdivision 1. **Rochester Area Medical Center Development Authority**

7.27 **established; membership.** (a) The Rochester Area Medical Center Development

7.28 Authority is established. The authority's governing board consists of eight voting members
 7.29 and two nonvoting members, as follows:

7.30 (1) the mayor of the city, or the mayor's designee, subject to approval by the city
 7.31 council;

7.32 (2) the city council president, or the city council president's designee, subject
 7.33 to approval by the city council;

7.34 (3) a representative of the medical business entity defined in section 469.41,
 7.35 subdivision 8, appointed by the mayor of the city, subject to approval of the city council;

8.1 (4) the chair of the county board, or the chair's designee, subject to approval by the
8.2 county board;

8.3 (5) a representative of the medical business entity defined in section 469.41,
8.4 subdivision 8, appointed by the governor;

8.5 (6) a resident of the city and a resident from outside of Olmsted County, appointed
8.6 by the governor;

8.7 (7) a representative from a statewide labor organization representing the building
8.8 trades, appointed by the governor;

8.9 (8) one member of the house of representatives who represents at least a portion
8.10 of the city of Rochester to serve as a nonvoting member, appointed by the speaker of
8.11 the house of representatives; and

8.12 (9) one member of the senate who represents at least a portion of the city of
8.13 Rochester to serve as a nonvoting member, appointed by the Subcommittee on Committees
8.14 of the senate Committee on Rules and Administration.

8.15 (b) Appointing authorities must make their appointments as soon as practicable after
8.16 the effective date of this section.

8.17 Subd. 2. **Terms.** (a) The term of a member first appointed after the effective date
8.18 of this section under subdivision 1, paragraph (a), clauses (1), (2), and (4), serves for a
8.19 term coterminous with the term of office.

8.20 (b) The term of a member first appointed after the effective date of this section under
8.21 subdivision 1, paragraph (a), clauses (3) and (6), serves from the date of appointment until
8.22 the first Tuesday after the first Monday in January 2017. Thereafter, members serve
8.23 six-year terms.

8.24 (c) The term of a member first appointed after the effective date of this section under
8.25 subdivision 1, paragraph (a), clauses (5) and (7), serves from the date of appointment until
8.26 the first Tuesday after the first Monday in January 2020. Thereafter, members serve
8.27 six-year terms.

8.28 (d) The nonvoting members serve for two years.

8.29 Subd. 3. **Vacancies.** A vacancy occurs:

8.30 (1) as provided in section 351.02;

8.31 (2) for a member appointed under subdivision 1, paragraph (a), clause (1) or (2),
8.32 when the mayor or city council president, respectively, ceases to hold office or ceases
8.33 to reside in the city, and under subdivision 1, paragraph (a), clause (4), when the chair
8.34 of the county board ceases to hold office;

8.35 (3) for a member appointed under subdivision 1, paragraph (a), clause (6), when
8.36 the member ceases to reside in the city;

9.1 (4) for a legislative appointee, if the member ceases to serve in the state legislature; or
 9.2 (5) upon a member's removal under subdivision 4.

9.3 A vacancy on the authority board must be filled by the appointing authority for the
 9.4 balance of the term subject to the same approval required for an appointment for a full
 9.5 term as provided in subdivision 1.

9.6 Subd. 4. **Removal.** A member may be removed by the board for inefficiency,
 9.7 neglect of duty, or misconduct in office. A member may be removed only after a hearing
 9.8 of the board. A copy of the charges must be given to the board member at least ten days
 9.9 before the hearing. The board member must be given an opportunity to be heard in person
 9.10 or by counsel at the hearing. When written charges have been submitted against a board
 9.11 member, the board may temporarily suspend the member. If the board finds that those
 9.12 charges have not been substantiated, the board member shall be immediately reinstated. If
 9.13 a board member is removed, a record of the proceedings, together with the charges and
 9.14 findings, shall be filed with the office of the appointing authority.

9.15 Subd. 5. **Pay.** Members must be compensated as provided in section 15.0575,
 9.16 subdivision 3, for each regular or special authority board meeting attended. In addition,
 9.17 the board members may be reimbursed for actual expenses incurred in doing official
 9.18 business of the authority. All money paid for compensation or reimbursement must be
 9.19 paid out of the authority's budget.

9.20 Subd. 6. **Conflicts of interest.** Except for the members appointed under subdivision
 9.21 1, paragraph (a), clauses (3) and (5), to represent the medical business entity, within one
 9.22 year prior to or at any time during a member's term of service on the authority's governing
 9.23 board, a member must not be employed by, be a member of the board of directors of, or
 9.24 otherwise be a representative of the medical business entity, as defined in section 469.41,
 9.25 subdivision 8, or the medical center economic development corporation, as defined in
 9.26 section 469.41, subdivision 10. No member may serve as a lobbyist, as defined under
 9.27 section 10A.01, subdivision 21.

9.28 **Sec. 8. [469.43] CHARACTERISTICS AND JURISDICTION.**

9.29 Subdivision 1. **Public body characteristics.** The authority is a body politic and
 9.30 corporate and a political subdivision of the state, with the right to sue and be sued in its
 9.31 own name. The authority carries out an essential government function of the state when it
 9.32 exercises its power, but the authority is not immune from liability because of this.

9.33 Subd. 2. **Boundaries.** The boundary for activities and the use of the powers of the
 9.34 authority must be within a medical center development district. The authority also has the
 9.35 power to finance activities outside of a medical center development district, if necessary;

10.1 provided, however, that the financing of activities outside of a medical center development
10.2 district must be included in the development plan and must be approved by, and subject to
10.3 the planning, zoning, sanitary and building laws, ordinances, regulations, and land use
10.4 plans applicable to, the city, county, or town in which such activities are undertaken.

10.5 **Sec. 9. [469.44] OFFICERS; DUTIES; ORGANIZATIONAL MATTERS.**

10.6 Subdivision 1. **Bylaws, rules, seal.** The authority may adopt bylaws and rules of
10.7 procedure and may adopt an official seal.

10.8 Subd. 2. **Officers.** The authority shall annually elect a president or chair, and a
10.9 vice-president or vice-chair, and a treasurer. A member may not serve as president or
10.10 chair and vice-president or vice-chair at the same time. The authority shall appoint a
10.11 secretary and assistant treasurer. The secretary and assistant treasurer need not, but may,
10.12 be members of the board, including the president or chair or vice-president or vice-chair.

10.13 Subd. 3. **Duties and powers.** The officers have the usual duties and powers of their
10.14 offices. They may be given other duties and powers by the authority.

10.15 Subd. 4. **Treasurer's duties.** The treasurer:

10.16 (1) shall receive and is responsible for authority money;

10.17 (2) is responsible for the acts of the assistant treasurer;

10.18 (3) shall disburse authority money by check or electronic procedures;

10.19 (4) shall keep an account of the source of all receipts, and the nature, purpose, and
10.20 authority of all disbursements; and

10.21 (5) shall file the authority's detailed financial statement with its secretary at least
10.22 once a year at times set by the authority.

10.23 Subd. 5. **Assistant treasurer.** The assistant treasurer has the powers and duties of
10.24 the treasurer if the treasurer is absent or disabled.

10.25 Subd. 6. **Treasurer's bond.** The treasurer shall give bond to the state conditioned
10.26 for the faithful discharge of official duties. The bond must be approved as to form and
10.27 surety by the authority and filed with its secretary. The bond must be for twice the amount
10.28 of money likely to be on hand at any one time, as determined at least annually by the
10.29 authority, except that the bond must not exceed \$300,000.

10.30 Subd. 7. **Public money.** Authority money is public money.

10.31 Subd. 8. **Checks.** An authority check must be signed by the treasurer and by one
10.32 other officer named by the authority in a resolution. The check must state the name of the
10.33 payee and the nature of the claim for which the check is issued.

10.34 Subd. 9. **Financial statements; filing with state auditor.** The financial statements
10.35 of the authority must be prepared, audited, filed, and published or posted in the manner

11.1 required for the financial statements of the city. The authority shall employ the state
 11.2 auditor or a certified public accountant to annually examine and audit its books. The
 11.3 report of the exam and audit must be filed with the state auditor by June 30 of each year.
 11.4 The state auditor shall review the report and may accept it or, in the public interest, audit
 11.5 the books of the authority.

11.6 Sec. 10. **[469.45] DEPOSITORIES; DEFAULT; COLLATERAL.**

11.7 Subdivision 1. **Named; bond.** Every two years the authority shall name national
 11.8 or state banks within the state as depositories. Before acting as a depository, a named
 11.9 bank shall give the authority a bond approved as to form and surety by the authority.
 11.10 The bond must be conditioned for the safekeeping and prompt repayment of deposits.
 11.11 The amount of the bond must be at least equal to the maximum sum expected to be on
 11.12 deposit at any one time.

11.13 Subd. 2. **Default; collateral.** When authority funds are deposited by the treasurer
 11.14 in a bonded depository, the treasurer and the surety on the treasurer's official bond are
 11.15 exempt from liability for the loss of the deposits because of the failure, bankruptcy, or any
 11.16 other act or default of the depository. The authority may accept assignments of collateral
 11.17 from its depository to secure deposits in the same manner as assignments of collateral are
 11.18 permitted by law to secure deposits of the city.

11.19 Sec. 11. **[469.47] TAX LEVIES; CITY OR COUNTY APPROPRIATIONS;**
 11.20 **OTHER FISCAL MATTERS.**

11.21 Subdivision 1. **Obligations.** The authority must not levy a tax or special assessment,
 11.22 pledge the credit of the state or the state's municipal corporations or other subdivisions, or
 11.23 incur an obligation enforceable on property not owned by the authority.

11.24 Subd. 2. **Budget.** The authority shall annually send its budget to the city, county,
 11.25 governor, and legislature.

11.26 Subd. 3. **Fiscal year.** The fiscal year of the authority may be established by the
 11.27 authority.

11.28 Subd. 4. **City or county appropriations; levy.** The city council of the city or the
 11.29 county board of the county may appropriate money for the use of the authority and may
 11.30 levy the amount of its appropriation in its general levy. The levy is a special levy within
 11.31 the meaning of, and as if specifically enumerated in, section 275.70, subdivision 5.

11.32 Subd. 5. **Outside budget laws.** Money appropriated to the authority by the city
 11.33 or county under this section is not subject to a budget law that applies to the city or
 11.34 county, respectively.

12.1 Subd. 6. **City or county payment.** The city or county treasurer shall pay money
12.2 appropriated by a city or county under subdivision 4 when and in the manner directed by
12.3 the city council or county board, as applicable.

12.4 Subd. 7. **Local government tax base not reduced.** Nothing in sections 469.41 to
12.5 469.53 reduces the tax base or affects the taxes due and payable to the city, the county, or
12.6 Independent School District No. 535, including, without limitation, the city's 0.5 percent
12.7 local sales tax.

12.8 Sec. 12. **[469.48] DEVELOPMENT PLAN; MEDICAL CENTER**
12.9 **DEVELOPMENT DISTRICTS.**

12.10 Subdivision 1. **Development plan; adoption by authority; notice; findings.** The
12.11 authority, in consultation with the medical center economic development corporation,
12.12 shall prepare a development plan with the city's involvement. The development plan must
12.13 be adopted by the board of the authority only after holding a public hearing. At least 45
12.14 days before the hearing, the authority shall file a copy of the proposed development plan
12.15 with the city. The city shall make copies of the proposed plan available to the public at
12.16 the city offices during normal business hours and as otherwise determined appropriate
12.17 by city council or city officials. At least ten days before the hearing, the authority shall
12.18 publish notice of the hearing in a daily newspaper of general circulation in the city. The
12.19 development plan may not be adopted unless the authority finds by resolution that:

12.20 (1) the plan provides an outline for the development of the city as a global destination
12.21 medical center, and the plan is sufficiently complete, including the identification of planned
12.22 and anticipated projects, to indicate its relationship to definite state and local objectives;

12.23 (2) the proposed development affords maximum opportunity, consistent with the
12.24 needs of the city, county, and state, for the development of the city by private enterprise as
12.25 a global destination medical center;

12.26 (3) the proposed development conforms to the general plan for the development
12.27 of the city; and

12.28 (4) the plan includes:

12.29 (i) strategic planning consistent with a global destination medical center in the
12.30 core areas of commercial research and technology, learning environment, hospitality
12.31 and convention, sports and recreation, livable communities, including mixed-use urban
12.32 development and neighborhood residential development, retail/dining/entertainment,
12.33 and health and wellness;

12.34 (ii) estimates of short- and long-range fiscal and economic impacts;

13.1 (iii) a framework to identify and prioritize short- and long-term public investment
 13.2 and infrastructure development and to facilitate private investment and development;

13.3 (iv) land use planning;

13.4 (v) transportation and transit planning;

13.5 (vi) operational planning required to support the medical center development
 13.6 district; and

13.7 (vii) ongoing market research plans.

13.8 **Subd. 2. Development plan; approval by city; finding.** After adoption by the
 13.9 authority under subdivision 1, the authority shall submit the development plan to the city
 13.10 for approval by the city only in accordance with this subdivision. The city shall approve
 13.11 the development plan by written resolution upon making the finding that the development
 13.12 plan is consistent with the adopted comprehensive plan of the city. The city shall consider
 13.13 the approval of the development plan and make its finding regarding consistency with
 13.14 the adopted comprehensive plan of the city within 45 days of submission of the adopted
 13.15 development plan. If the city determines, by written resolution, that the development plan
 13.16 is not consistent with the adopted comprehensive plan of the city, the resolution shall state
 13.17 the reasons and supporting facts for each determination, and the city shall transmit the
 13.18 resolution to the authority within seven days of adoption. A revised development plan
 13.19 may be submitted by the authority for approval by the city in the manner provided in this
 13.20 subdivision. The city may incorporate the approved development plan into the city's
 13.21 comprehensive plan.

13.22 **Subd. 3. Modification of development plan.** The authority may modify the
 13.23 development plan at any time. The authority shall update the original development plan
 13.24 not less than every five years. A modification or update under this subdivision must be
 13.25 prepared with the city's involvement and adopted by the authority upon the notice and
 13.26 after the public hearing and findings required for the original adoption of the development
 13.27 plan and upon approval by the city as provided in subdivision 2.

13.28 **Subd. 4. Medical center development districts; creation; notice; findings.** As
 13.29 part of the development plan, the authority may create and define the boundaries of
 13.30 medical center development districts and subdistricts at any place or places within the
 13.31 city. Projects may be undertaken within defined medical center development districts
 13.32 consistent with the development plan.

13.33 **Subd. 5. Policy.** It is state policy in the public interest to have the authority exercise
 13.34 the power of eminent domain to acquire property for a public use, as defined in section
 13.35 117.025, and advance and spend money for the purposes in sections 469.41 to 469.53.

14.1 Sec. 13. **[469.49] POWERS AND DUTIES.**

14.2 **Subdivision 1. Powers generally.** The authority has the powers of a city under
14.3 chapter 462C and the powers of a redevelopment agency under sections 469.152 to
14.4 469.1651, in connection with private development in the city for which the authority
14.5 has previously undertaken or concurrently undertakes a project financed in whole or in
14.6 part with authority revenue or obligations issued pursuant to section 469.50; provided,
14.7 however, the authority shall not enter into any revenue agreement pursuant to section
14.8 469.155, subdivision 5, with a medical business entity.

14.9 **Subd. 2. Projects; project costs.** The authority may, within a medical center
14.10 development district, undertake projects and finance project costs. The authority must
14.11 find by resolution that the project is consistent with and in furtherance of the approved
14.12 development plan. Subject to other applicable law, revenue derived by the authority
14.13 from any source may be used by the authority to make loans or grants, or to provide
14.14 direct or indirect financial support to state public bodies or to private entities in payment
14.15 or reimbursement of project costs; provided, however, projects as defined under section
14.16 469.41, subdivision 11, clauses (4), (5), and (6), which will be owned, operated, or
14.17 maintained by the city, must be approved by written resolution of the city.

14.18 **Subd. 3. Medical center economic development corporation.** (a) The authority
14.19 shall engage a medical center economic development corporation to advise the authority
14.20 on matters related to a project. The provisions of section 465.717 do not apply to any
14.21 entity serving as the medical center economic development corporation. The medical
14.22 center economic development corporation shall assist the authority in the preparation of
14.23 the development plan and shall provide services to assist the authority in implementing,
14.24 consistent with the development plan, the goals, objectives, and strategies in the
14.25 development plan, including, without limitation:

14.26 (1) developing and updating the criteria for evaluating and underwriting
14.27 development proposals;

14.28 (2) implementing the development plan, including soliciting and evaluating
14.29 proposals for development and evaluating and making recommendations to the authority
14.30 regarding those proposals;

14.31 (3) providing transactional services in connection with approved projects;

14.32 (4) developing patient, visitor, and community outreach programs for a medical
14.33 center development district;

14.34 (5) working with the authority to acquire and facilitate the sale, lease, or other
14.35 transactions involving land and real property;

14.36 (6) seeking financial support for itself, the authority, and a project;

15.1 (7) partnering with other development agencies and organizations and the city and
15.2 county in joint efforts to promote economic development and establish a destination
15.3 medical center;

15.4 (8) supporting and administering the planning and development activities required to
15.5 implement the development plan;

15.6 (9) preparing and supporting the marketing and promotion of the medical center
15.7 development district;

15.8 (10) preparing and implementing a program for community and public relations in
15.9 support of the medical center development district;

15.10 (11) assisting the authority and others in applications for federal grants, tax credits,
15.11 and other sources of funding to aid both private and public development; and

15.12 (12) making other general advisory recommendations to the authority's governing
15.13 board, as requested.

15.14 (b) The authority may contract with the medical center economic development
15.15 corporation to provide administrative services to the authority. The authority may agree to
15.16 provide reasonable compensation to the medical center economic development corporation
15.17 for the services described in this section. The authority may pay for such services out of
15.18 any revenue sources available to it, including amounts received from the city or the county
15.19 under section 469.47 or from payments received from the state under section 469.53.
15.20 Nothing in sections 469.40 to 469.53 shall relieve the authority's governing board of its
15.21 duties and powers to adopt the development plan or to exercise the judgment or discretion
15.22 of the authority to finance projects or otherwise expend public funds.

15.23 Subd. 4. **Revenue pooling.** The authority may deposit all its money from any
15.24 source in one bank account.

15.25 Subd. 5. **Acquire property; exemption for taxes.** (a) The authority may acquire by
15.26 lease, purchase, gift, or devise the needed right, title, and interest in property to create
15.27 medical center development districts and undertake projects. The authority may exercise
15.28 the power of eminent domain to acquire property for a public use, as defined in section
15.29 117.025. It shall pay for the property out of money it receives under sections 469.41 to
15.30 469.53. It may hold and dispose of the property subject to the limits and conditions in
15.31 sections 469.41 to 469.53. The title to property acquired by condemnation or purchase
15.32 must be in fee simple, absolute. The authority may accept an interest in property acquired
15.33 in another way subject to any condition of the grantor or donor. The condition must
15.34 be consistent with the proper use of the property under sections 469.41 to 469.53. The
15.35 authority may sign options to purchase, sell, or lease property.

16.1 (b) Property acquired, owned, leased, controlled, used, or occupied by the authority
16.2 for any of the purposes of this section is for public governmental and municipal purposes
16.3 and is exempt from taxation by the state or its political subdivisions, except to the extent
16.4 that the property is subject to the sales and use tax under chapter 297A. The exemption in
16.5 this paragraph applies only while the authority holds property for its own purpose, and is
16.6 subject to section 272.02, subdivisions 38 and 39. When the property is sold it becomes
16.7 subject to taxation.

16.8 Subd. 6. **Subject to city requirements.** All projects and development plans are
16.9 subject to the planning, zoning, sanitary, and building laws, ordinances, regulations,
16.10 and land use plans applicable to the city.

16.11 Subd. 7. **Sale of property.** The authority may sell, convey, and exchange any real or
16.12 personal property owned or held by it in any manner and on any terms it wishes. Real
16.13 property owned by the authority must not be sold, conveyed, exchanged, or have its title
16.14 transferred without approval of two-thirds of the members of the board. All members
16.15 must have ten days' written notice of a regular or special meeting at which a vote on sale,
16.16 conveyance, exchange, or transfer of real property is to be taken. The notice must contain
16.17 a complete description of the affected real property. The resolution authorizing the real
16.18 property transaction is not effective unless a quorum is present.

16.19 Subd. 8. **Contracts.** The authority may make contracts for the purpose of economic
16.20 development within the powers given it in sections 469.41 to 469.53. The authority
16.21 may contract or arrange with the federal government, or any of its departments, with
16.22 persons, public corporations, the state, or any of its political subdivisions, commissions, or
16.23 agencies, for separate or joint action, on any matter related to using the authority's powers
16.24 or performing its duties. The authority may contract to purchase and sell real and personal
16.25 property. An obligation or expense must not be incurred by the authority unless existing
16.26 appropriations together with the reasonably expected revenue of the authority from other
16.27 sources are sufficient to discharge the obligation or pay the expense when due. The state
16.28 and its municipal subdivisions are not liable on the obligations of the authority.

16.29 Subd. 9. **Contracts for services.** The authority may contract for the services of
16.30 consultants, including the medical center economic development corporation, and agents,
16.31 public accountants, legal counsel, and other persons needed to assist the authority in
16.32 performing its duties and exercising its powers. The authority may contract with the city
16.33 or county to provide administrative, clerical, and accounting services to the authority.
16.34 Nothing in sections 469.40 to 469.53 relieves the authority's governing board of its duties
16.35 and powers to adopt the development plan or to exercise the judgment or discretion of the
16.36 authority to finance projects or otherwise expend public funds. Any contract for services

17.1 between the authority and the medical center development corporation paid, in whole or
17.2 in part, with public money shall give the authority and the state auditor the right to audit
17.3 the books and records of the medical center development corporation that are necessary
17.4 to certify (1) the nature and extent of the services furnished pursuant to the contract,
17.5 and (2) that the payment for services and related disbursements complies with all state
17.6 laws, regulations, and the terms of the contract. Any contract for services between the
17.7 authority and the medical center development corporation paid, in whole or in part, with
17.8 public money shall require the authority to maintain, during the term of the contract,
17.9 and for a period of at least ... years thereafter, accurate and complete books and records
17.10 directly relating to the contract.

17.11 Subd. 10. **Supplies.** The authority may purchase the supplies and materials it needs
17.12 to carry out sections 469.41 to 469.53.

17.13 Subd. 11. **City purchasing.** The authority may, by agreement with the city, use the
17.14 facilities and services of the city's purchasing and public works departments in connection
17.15 with construction work and to purchase equipment, supplies, or materials.

17.16 Subd. 12. **City facilities, services.** The city may furnish offices, structures and
17.17 space, and clerical, engineering, or other services or assistance to the authority.

17.18 Subd. 13. **Delegation power.** The authority may delegate to one or more of its
17.19 agents powers or duties as it deems proper.

17.20 Subd. 14. **Government agent.** The authority may cooperate with or act as agent
17.21 for the federal or state government, a state public body, or an agency or instrumentality
17.22 of a government or a public body to carry out sections 469.41 to 469.53 or any other
17.23 related federal, state, or local law.

17.24 Subd. 15. **Studies, analysis, research.** The authority may study and analyze
17.25 development needs in a medical center development district and ways to meet the needs.
17.26 The authority may study the desirable patterns for land use and community growth and
17.27 other factors affecting local development in a medical center development district and
17.28 make the result of the studies available to the public and to potential developers. The
17.29 authority may engage in research and disseminate information on development in its
17.30 medical center development districts.

17.31 Subd. 16. **Acceptance of public land.** The authority may accept conveyances of
17.32 land from all other public agencies, commissions, or other units of government, if the land
17.33 can be properly used by the authority in a medical center development district, to carry
17.34 out the purposes of sections 469.41 to 469.53. The city council of the city may transfer
17.35 or cause to be transferred to the authority any property owned or controlled by the city
17.36 and located within the jurisdiction of the authority. The transfer must be approved by

18.1 majority vote of the city council and may be with or without consideration. The city may
18.2 also put the property in the possession or control of the authority by a lease or other
18.3 agreement for a limited period or in fee.

18.4 Subd. 17. **Loans in anticipation of bonds.** After authorizing bonds under section
18.5 469.50, the authority may borrow to provide money immediately required for the bond
18.6 purposes. The loans may not exceed the amount of the bonds. The authority shall by
18.7 resolution decide the terms of the loans. The loans must be evidenced by negotiable
18.8 notes due in not more than 12 months from the date of the loan payable to the order of
18.9 the lender, to be repaid with interest from the proceeds of the bonds when the bonds are
18.10 issued and delivered to the bond purchasers. The loan must not be obtained from any
18.11 board member of the authority or from any corporation, association, or other institution of
18.12 which an authority board member is a stockholder or officer.

18.13 Subd. 18. **Reporting requirements.** On or before January 1 of each odd-numbered
18.14 year, the authority shall provide a report to the legislature, the commissioners of
18.15 management and budget, revenue, and employment and economic development, the city
18.16 council, and the county board of commissioners. The report must provide calculations
18.17 of dedicated state taxes for the prior two fiscal years of the authority, a current draft of
18.18 the development plan, and debt service schedules for all outstanding bonds or notes of
18.19 the authority.

18.20 Subd. 19. **No tax increment financing powers.** The authority is not an authority as
18.21 defined in section 469.174, subdivision 2.

18.22 Sec. 14. **[469.50] REVENUE OBLIGATIONS; PLEDGE; COVENANTS.**

18.23 Subdivision 1. **Powers.** The authority may decide by resolution to issue its revenue
18.24 bonds, notes, or other obligations either at one time or in series from time to time. The
18.25 revenue bonds may be issued to provide money to pay project costs. The issued bonds
18.26 may include the amount the authority considers necessary to establish an initial reserve to
18.27 pay principal of and interest on the bonds, including capitalized interest, and to pay the
18.28 costs of issuance. The resolution shall state how the bonds are to be executed.

18.29 Subd. 2. **Form.** The bonds of each series issued by the authority under this section
18.30 must bear interest at the rate or rates, mature at times not later than 30 years from the date
18.31 of issuance, and be fully registered bonds in the form determined by the authority. All
18.32 bonds issued under this section must be negotiable instruments.

18.33 Subd. 3. **Sale.** The sale of revenue bonds issued by the authority may be at public or
18.34 private sale. The bonds may be sold in the manner and for the amount that the authority

19.1 determines to be in the best interest of the authority. The bonds may be made callable upon
19.2 terms as determined by the authority and may be refunded as provided in section 475.67.

19.3 Subd. 4. **Agreements.** The authority may by resolution make an agreement or
19.4 covenant with the bondholders or their trustee if it determines that the agreement or
19.5 covenant is needed or desirable to carry out the powers given to the authority under this
19.6 section and to ensure that the revenue bonds are marketable and promptly paid.

19.7 Subd. 5. **Revenue pledge.** (a) In issuing bonds under this section, the authority may
19.8 secure payment of the principal and interest on the bonds by:

19.9 (1) a pledge of and lien on authority revenue. The revenue must come from the
19.10 facility to be acquired, constructed, or improved with the bond proceeds or from other
19.11 facilities named in the bond-authorizing resolutions. The authority also may secure the
19.12 payment with its promise to impose, maintain, and collect enough rentals, rates, and
19.13 charges, for the use and occupancy of the facilities and for services furnished in connection
19.14 with the use and occupancy, to pay its current expenses to operate and maintain the named
19.15 facilities, and to produce and deposit sufficient net revenue in a special fund to meet the
19.16 interest and principal requirements of the bonds, and to collect and keep any more money
19.17 required by the resolutions. The authority shall decide what constitutes "current" expense
19.18 under this subdivision based on what is normal and reasonable under generally accepted
19.19 accounting principles. Revenues pledged by the authority must not be used or pledged for
19.20 any other authority purpose unless the other use or pledge is specifically authorized in the
19.21 bond-authorizing resolutions; or

19.22 (2) the payments to be made by the state to the authority under section 469.53.
19.23 The aggregate principal amount of bonds issued under this clause may not exceed
19.24 \$585,000,000, less the principal amount of any city grant, bond, or note given or issued to
19.25 finance project costs consistent with the development plan up to \$60,000,000.

19.26 (b) No bonds may be issued by the authority under this subdivision later than
19.27 20 years from the date of final enactment of this act, and no bond issued under this
19.28 subdivision may have a maturity later than December 31, 2049.

19.29 Subd. 6. **Approval of commissioner of employment and economic development.**

19.30 (a) Prior to issuance of each series of bonds, notes, or other obligations under subdivision
19.31 5, clause (2), the authority shall furnish to the commissioner of employment and economic
19.32 development, in the form prescribed by the commissioner, the following information
19.33 regarding a project:

19.34 (1) the amount of bonds to be issued for the project;

19.35 (2) the maximum annual debt service payable on the bonds in any year;

19.36 (3) the proposed use, location, and ownership of the project;

- 20.1 (4) other sources of funds for the project; and
20.2 (5) the specific uses of the proceeds of the bonds.

20.3 For purposes of determining the maximum annual debt service under clause (2), for
20.4 variable rate obligations, interest rates must be determined as the maximum rate of interest
20.5 payable on the obligations in accordance with their terms.

20.6 (b) In addition, the authority shall certify that the project is consistent with the
20.7 development plan and that debt service in any year on all bonds then outstanding and the
20.8 bonds proposed to be issued under subdivision 5, clause (2), does not exceed the value
20.9 capture amount calculated within the prior 12 months as determined under section 469.53,
20.10 subdivision 2, paragraph (b).

20.11 (c) Based upon the information provided by the authority, the commissioner
20.12 of employment and economic development shall approve the issuance of that series
20.13 of authority bonds as consistent with the requirements of sections 469.41 to 469.53,
20.14 and the commissioner of employment and economic development shall promptly
20.15 notify the authority and the commissioner of management and budget of its approval;
20.16 provided, however, that the approval is not deemed an approval by the commissioner of
20.17 employment and economic development or by the state of the feasibility of the project.
20.18 The commissioner of employment and economic development shall keep a record of the
20.19 information, which shall be available to the public at times the department prescribes.

20.20 Subd. 7. **Not city, county, or state debt.** Revenue bonds, notes, or other obligations
20.21 issued under this section are not a debt of the city, county, or state, nor a pledge of the full
20.22 faith and credit of the city, county, or state. All obligations under this section are payable
20.23 only from revenues described in subdivision 5. A revenue bond must contain on its face a
20.24 statement to the effect that the authority does not have to pay the bond or the interest on it
20.25 except from the revenues pledged thereto and that the faith, credit, and taxing power of the
20.26 city, the county, and the state are not pledged to pay the principal of or interest on the bond.

20.27 Sec. 15. **[469.51] CITY BONDS; PUBLIC IMPROVEMENTS.**

20.28 The city may issue bonds and appropriate bond proceeds to pay project costs
20.29 consistent with the development plan within a medical center development district. The city
20.30 may undertake public improvements and infrastructure projects to be owned by the city or
20.31 make grants to the authority for such public improvements and infrastructure projects in the
20.32 same manner as if the facilities were owned or to be owned or operated solely by the city.

20.33 Sec. 16. **[469.52] WHEN BOND ALLOCATION ACT APPLIES.**

21.1 Sections 474A.01 to 474A.21 apply to obligations issued under sections 469.41 to
21.2 469.53 that are limited by a federal tax law as defined in section 474A.02, subdivision 8.

21.3 **Sec. 17. [469.53] PAYMENTS TO AUTHORITY; CONDITIONS.**

21.4 Subdivision 1. **Conditions of payment; amount.** Before the commissioner of
21.5 management and budget may make any payments authorized in this section to the
21.6 authority, the commissioner must have received, for payments to be made in state fiscal
21.7 year 2016 and later years, the commissioner of revenue's reports required by subdivision
21.8 2, paragraph (b), a request from the authority showing the amount of the payment
21.9 requested for debt service on bonds, notes, and other obligations of the authority and for
21.10 operating and administrative expenses of the authority and, if not previously received, the
21.11 approval by the commissioner of employment and economic development of the bonds for
21.12 which payment is being requested; provided, however, in no event shall the commissioner
21.13 of management and budget transfer an appropriation of more than \$75,000,000 to the
21.14 authority in any state fiscal year.

21.15 Subd. 2. **Calculation of designated state tax amount.** (a) The commissioner of
21.16 revenue shall determine the amount of each of the designated state taxes attributable
21.17 to calendar year 2011, which shall be referred to as the "baseline designated state tax
21.18 amount." The commissioner of revenue may retain an independent consultant to assist
21.19 with this determination. The amount necessary to pay for any consultant retained by the
21.20 commissioner of revenue is appropriated from the general fund to the commissioner
21.21 and is deducted from any amount transferred to the authority under this section. The
21.22 calculation of designated state tax amounts must be based on (1) direct employment tax
21.23 data provided by any medical business entity, and (2) other direct and indirect methods of
21.24 measurement used by the commissioner of revenue. The commissioner of revenue shall
21.25 make the determination and provide to the authority, the legislature, the commissioners
21.26 of management and budget, and employment and economic development, the city, and
21.27 the county a report showing the baseline designated state tax amounts no later than July
21.28 15, 2013.

21.29 (b) On or before April 1, 2014, the commissioner of revenue shall determine the
21.30 amount of designated state taxes attributable to calendar year 2013, and shall provide
21.31 to the authority, the legislature, the commissioners of management and budget, and
21.32 employment and economic development, the city, and the county a report showing the
21.33 designated state taxes attributable to calendar year 2013, and the increases, if any, over
21.34 the baseline designated state tax amounts. The commissioner of revenue may retain an
21.35 independent consultant to assist with this determination. The amount necessary to pay for

22.1 any consultant retained by the commissioner of revenue is appropriated from the general
22.2 fund to the commissioner and is deducted from any amount transferred to the authority
22.3 under this section. The report shall also show the results of the following formula:
22.4 designated state taxes attributable to calendar year 2013 minus baseline designated state
22.5 tax amounts, the difference of which is divided by 1.5. The result of the application of
22.6 this formula to designated state taxes for any calendar year constitutes the "value capture
22.7 amount." A similar report showing the designated state taxes attributable to the preceding
22.8 calendar year and the value capture amount based on such taxes shall be prepared and
22.9 delivered as described in this paragraph not later than April 1 in each subsequent year if
22.10 requested by the authority no later than March 1 of that year.

22.11 Subd. 3. **Payments.** After the report in subdivision 2, paragraph (a), showing the
22.12 baseline designated state tax amounts is provided to the commissioner of management and
22.13 budget by the commissioner of revenue, the commissioner of management and budget
22.14 shall transfer to the authority, on July 15 of each year commencing July 15, 2015, and
22.15 for so long thereafter as any bonds, notes, or other obligations issued by the authority
22.16 under section 469.50, subdivision 5, clause (2), remain outstanding, the annual payments
22.17 requested by the authority under subdivision 1.

22.18 Subd. 4. **Appropriations.** In each state fiscal year, beginning in fiscal year 2016 to
22.19 and including fiscal year 2049, there is appropriated to the commissioner of management
22.20 and budget for transfer to the authority the amount of debt service for the state fiscal year
22.21 on outstanding authority bonds issued pursuant to section 469.50, subdivision 5, clause
22.22 (2), plus operating and administrative expense of the authority for such year, but subject to
22.23 the limitations of subdivision 1 of this section.
