1.1 A bill for an act
1.2 relating to state lands; modifying requirements for conveying easements and leasing
1.3 state lands; adding to and deleting from state forests; adding to state parks;
1.4 authorizing sales and conveyances of certain land; amending Minnesota Statutes
1.5 2022, sections 84.63; 84.631; 84.632; 92.502; 282.04, subdivision 1, by adding a
1.6 subdivision; repealing Laws 2012, chapter 236, section 28, subdivision 9, as
1.7 amended.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2022, section 84.63, is amended to read:

1.10 84.63 CONVEYING INTERESTS IN LANDS TO STATE, FEDERAL, AND
1.11 TRIBAL GOVERNMENTS.

1.12 (a) Notwithstanding any existing law to the contrary, the commissioner of natural
1.13 resources is hereby authorized on behalf of the state to convey to the United States, to a
1.14 federally recognized Indian Tribe, or to the state of Minnesota or any of its subdivisions,
1.15 upon state-owned lands under the administration of the commissioner of natural resources,
1.16 permanent or temporary easements for specified periods or otherwise for trails, highways,
1.17 roads including limitation of right of access from the lands to adjacent highways and roads,
1.18 flowage for development of fish and game resources, stream protection, flood control, and
1.19 necessary appurtenances thereto, such conveyances to be made upon such terms and
1.20 conditions including provision for reversion in the event of non-user as the commissioner
1.21 of natural resources may determine.

1.22 (b) In addition to the fee for the market value of the easement, the commissioner of
1.23 natural resources shall assess the applicant the following fees:

2.1 (1) an application fee of \$2,000 to cover reasonable costs for reviewing the application
2.2 and preparing the easement; and

2.3 (2) a monitoring fee to cover the projected reasonable costs for monitoring the
2.4 construction of the improvement for which the easement was conveyed and preparing special
2.5 terms and conditions for the easement. The commissioner must give the applicant an estimate
2.6 of the monitoring fee before the applicant submits the fee.

2.7 (c) The applicant shall pay these fees to the commissioner of natural resources. The
2.8 commissioner shall not issue the easement until the applicant has paid in full the application
2.9 fee, the monitoring fee, and the market value payment for the easement.

2.10 (d) Upon completion of construction of the improvement for which the easement was
2.11 conveyed, the commissioner shall refund the unobligated balance from the monitoring fee
2.12 revenue. The commissioner shall not return the application fee, even if the application is
2.13 withdrawn or denied.

2.14 (e) Money received under paragraph (b) must be deposited in the land management
2.15 account in the natural resources fund and is appropriated to the commissioner of natural
2.16 resources to cover the reasonable costs incurred for issuing and monitoring easements.

2.17 (f) A county or joint county regional railroad authority is exempt from all fees specified
2.18 under this section for trail easements on state-owned land.

2.19 (g) In addition to fees specified in this section, the applicant must reimburse the state
2.20 for costs incurred for cultural resources review, monitoring, or other services provided by
2.21 the Minnesota Historical Society under contract with the commissioner of natural resources
2.22 or the State Historic Preservation Office of the Department of Administration in connection
2.23 with the easement application, preparing the easement terms, or constructing the trail,
2.24 highway, road, or other improvements.

2.25 (h) Notwithstanding paragraphs (a) to (g), the commissioner of natural resources may
2.26 elect to assume the application fee under paragraph (b), clause (1), and waive or assume
2.27 some or all of the remaining fees and costs imposed under this section if the commissioner
2.28 determines that issuing the easement will benefit the state's land management interests.

2.29 Sec. 2. Minnesota Statutes 2022, section 84.631, is amended to read:

2.30 **84.631 ROAD EASEMENTS ACROSS STATE LANDS.**

2.31 (a) Except as provided in section 85.015, subdivision 1b, the commissioner of natural
2.32 resources, on behalf of the state, may convey a road easement across state land under the

3.1 commissioner's jurisdiction to a private person requesting an easement for access to property
3.2 owned by the person only if the following requirements are met:

3.3 (1) there are no reasonable alternatives to obtain access to the property; and

3.4 (2) the exercise of the easement will not cause significant adverse environmental or
3.5 natural resource management impacts.

3.6 (b) The commissioner shall:

3.7 (1) require the applicant to pay the market value of the easement;

3.8 (2) limit the easement term to 50 years if the road easement is across school trust land;

3.9 (3) provide that the easement reverts to the state in the event of nonuse; and

3.10 (4) impose other terms and conditions of use as necessary and appropriate under the
3.11 circumstances.

3.12 (c) An applicant shall submit an application fee of \$2,000 with each application for a
3.13 road easement across state land. The application fee is nonrefundable, even if the application
3.14 is withdrawn or denied.

3.15 (d) In addition to the payment for the market value of the easement and the application
3.16 fee, the commissioner of natural resources shall assess the applicant a monitoring fee to
3.17 cover the projected reasonable costs for monitoring the construction of the road and preparing
3.18 special terms and conditions for the easement. The commissioner must give the applicant
3.19 an estimate of the monitoring fee before the applicant submits the fee. The applicant shall
3.20 pay the application and monitoring fees to the commissioner of natural resources. The
3.21 commissioner shall not issue the easement until the applicant has paid in full the application
3.22 fee, the monitoring fee, and the market value payment for the easement.

3.23 (e) Upon completion of construction of the road, the commissioner shall refund the
3.24 unobligated balance from the monitoring fee revenue.

3.25 (f) Fees collected under paragraphs (c) and (d) must be credited to the land management
3.26 account in the natural resources fund and are appropriated to the commissioner of natural
3.27 resources to cover the reasonable costs incurred under this section.

3.28 (g) In addition to fees specified in this section, the applicant must reimburse the state
3.29 for costs incurred for cultural resources review, monitoring, or other services provided by
3.30 the Minnesota Historical Society under contract with the commissioner of natural resources
3.31 or the State Historic Preservation Office of the Department of Administration in connection
3.32 with the easement application, preparing the easement terms, or constructing the road.

4.1 (h) Notwithstanding paragraphs (a) to (g), the commissioner of natural resources may
4.2 elect to assume the application fee under paragraph (c) and waive or assume some or all of
4.3 the remaining fees and costs imposed under this section if the commissioner determines
4.4 that issuing the easement will benefit the state's land management interests.

4.5 Sec. 3. Minnesota Statutes 2022, section 84.632, is amended to read:

4.6 **84.632 CONVEYANCE OF UNNEEDED STATE EASEMENTS.**

4.7 (a) Notwithstanding section 92.45, the commissioner of natural resources may, in the
4.8 name of the state, release all or part of an easement acquired by the state upon application
4.9 of a landowner whose property is burdened with the easement if the easement is not needed
4.10 for state purposes.

4.11 (b) All or part of an easement may be released by payment of the market value of the
4.12 easement. The release must be in a form approved by the attorney general.

4.13 (c) Money received under paragraph (b) must be credited to the account from which
4.14 money was expended for purchase of the easement. If there is no specific account, the money
4.15 must be credited to the land acquisition account established in section 94.165.

4.16 (d) In addition to payment under paragraph (b), the commissioner of natural resources
4.17 shall assess a landowner who applies for a release under this section an application fee of
4.18 \$2,000 for reviewing the application and preparing the release of easement. The applicant
4.19 shall pay the application fee to the commissioner of natural resources. The commissioner
4.20 shall not issue the release of easement until the applicant has paid the application fee in full.
4.21 The commissioner shall not return the application fee, even if the application is withdrawn
4.22 or denied.

4.23 (e) Money received under paragraph (d) must be credited to the land management account
4.24 in the natural resources fund and is appropriated to the commissioner of natural resources
4.25 to cover the reasonable costs incurred under this section.

4.26 (f) Notwithstanding paragraphs (a) to (e), the commissioner of natural resources may
4.27 elect to assume the application fee under paragraph (d) and waive or assume some or all of
4.28 the remaining fees and costs imposed under this section if the commissioner determines
4.29 that issuing the easement release will benefit the state's land management interests.

5.1 Sec. 4. Minnesota Statutes 2022, section 92.502, is amended to read:

5.2 **92.502 LEASING TAX-FORFEITED AND STATE LANDS.**

5.3 (a) Notwithstanding section 282.04 or other law to the contrary, St. Louis County may
5.4 enter a 30-year lease of tax-forfeited land for a wind energy project.

5.5 (b) The commissioner of natural resources may enter a 30-year lease of land administered
5.6 by the commissioner for a wind energy project.

5.7 (c) The commissioner of natural resources may enter a 30-year lease of land administered
5.8 by the commissioner for recreational trails ~~and~~ or facilities. The commissioner may assess
5.9 the lease applicant a monitoring fee to cover the projected reasonable costs of monitoring
5.10 construction of the recreational trail or facility and preparing special terms and conditions
5.11 of the license to ensure proper construction. The commissioner must give the applicant an
5.12 estimate of the monitoring fee before the applicant is required to submit the fee. Upon
5.13 completion of construction of the trail or facility, the commissioner must refund the
5.14 unobligated balance from the monitoring fee revenue.

5.15 (d) Notwithstanding section 282.04 or other law to the contrary, Lake and St. Louis
5.16 Counties may enter into 30-year leases of tax-forfeited land for recreational trails and
5.17 facilities.

5.18 Sec. 5. Minnesota Statutes 2022, section 282.04, subdivision 1, is amended to read:

5.19 Subdivision 1. **Timber sales; land leases and uses.** (a) The county auditor, with terms
5.20 and conditions set by the county board, may sell timber upon any tract that may be approved
5.21 by the natural resources commissioner. The sale of timber shall be made for cash at not less
5.22 than the appraised value determined by the county board to the highest bidder after not less
5.23 than one week's published notice in an official paper within the county. Any timber offered
5.24 at the public sale and not sold may thereafter be sold at private sale by the county auditor
5.25 at not less than the appraised value thereof, until the time as the county board may withdraw
5.26 the timber from sale. The appraised value of the timber and the forestry practices to be
5.27 followed in the cutting of said timber shall be approved by the commissioner of natural
5.28 resources.

5.29 (b) Payment of the full sale price of all timber sold on tax-forfeited lands shall be made
5.30 in cash at the time of the timber sale, except in the case of oral or sealed bid auction sales,
5.31 the down payment shall be no less than 15 percent of the appraised value, and the balance
5.32 shall be paid prior to entry. In the case of auction sales that are partitioned and sold as a
5.33 single sale with predetermined cutting blocks, the down payment shall be no less than 15

6.1 percent of the appraised price of the entire timber sale which may be held until the satisfactory
6.2 completion of the sale or applied in whole or in part to the final cutting block. The value of
6.3 each separate block must be paid in full before any cutting may begin in that block. With
6.4 the permission of the county contract administrator the purchaser may enter unpaid blocks
6.5 and cut necessary timber incidental to developing logging roads as may be needed to log
6.6 other blocks provided that no timber may be removed from an unpaid block until separately
6.7 scaled and paid for. If payment is provided as specified in this paragraph as security under
6.8 paragraph (a) and no cutting has taken place on the contract, the county auditor may credit
6.9 the security provided, less any down payment required for an auction sale under this
6.10 paragraph, to any other contract issued to the contract holder by the county under this chapter
6.11 to which the contract holder requests in writing that it be credited, provided the request and
6.12 transfer is made within the same calendar year as the security was received.

6.13 (c) The county board may sell any timber, including biomass, as appraised or scaled.
6.14 Any parcels of land from which timber is to be sold by scale of cut products shall be so
6.15 designated in the published notice of sale under paragraph (a), in which case the notice shall
6.16 contain a description of the parcels, a statement of the estimated quantity of each species
6.17 of timber, and the appraised price of each species of timber for 1,000 feet, per cord or per
6.18 piece, as the case may be. In those cases any bids offered over and above the appraised
6.19 prices shall be by percentage, the percent bid to be added to the appraised price of each of
6.20 the different species of timber advertised on the land. The purchaser of timber from the
6.21 parcels shall pay in cash at the time of sale at the rate bid for all of the timber shown in the
6.22 notice of sale as estimated to be standing on the land, and in addition shall pay at the same
6.23 rate for any additional amounts which the final scale shows to have been cut or was available
6.24 for cutting on the land at the time of sale under the terms of the sale. Where the final scale
6.25 of cut products shows that less timber was cut or was available for cutting under terms of
6.26 the sale than was originally paid for, the excess payment shall be refunded from the forfeited
6.27 tax sale fund upon the claim of the purchaser, to be audited and allowed by the county board
6.28 as in case of other claims against the county. No timber, except hardwood pulpwood, may
6.29 be removed from the parcels of land or other designated landings until scaled by a person
6.30 or persons designated by the county board and approved by the commissioner of natural
6.31 resources. Landings other than the parcel of land from which timber is cut may be designated
6.32 for scaling by the county board by written agreement with the purchaser of the timber. The
6.33 county board may, by written agreement with the purchaser and with a consumer designated
6.34 by the purchaser when the timber is sold by the county auditor, and with the approval of
6.35 the commissioner of natural resources, accept the consumer's scale of cut products delivered
6.36 at the consumer's landing. No timber shall be removed until fully paid for in cash. Small

7.1 amounts of timber not exceeding 500 cords in appraised volume may be sold for not less
7.2 than the full appraised value at private sale to individual persons without first publishing
7.3 notice of sale or calling for bids, provided that in case of a sale involving a total appraised
7.4 value of more than \$200 the sale shall be made subject to final settlement on the basis of a
7.5 scale of cut products in the manner above provided and not more than two of the sales,
7.6 directly or indirectly to any individual shall be in effect at one time.

7.7 (d) As directed by the county board, the county auditor may lease tax-forfeited land to
7.8 individuals, corporations or organized subdivisions of the state at public or private sale, and
7.9 at the prices and under the terms as the county board may prescribe, for use as cottage and
7.10 camp sites and for agricultural purposes and for the purpose of taking and removing of hay,
7.11 stumpage, sand, gravel, clay, rock, marl, and black dirt from the land, and for garden sites
7.12 and other temporary uses provided that no leases shall be for a period to exceed ~~ten~~ 25 years;
7.13 provided, further that any leases involving a consideration of more than ~~\$12,000~~ \$50,000
7.14 per year, except to an organized subdivision of the state shall first be offered at public sale
7.15 in the manner provided herein for sale of timber. Upon the sale of any leased land, it shall
7.16 remain subject to the lease for not to exceed one year from the beginning of the term of the
7.17 lease. Any rent paid by the lessee for the portion of the term cut off by the cancellation shall
7.18 be refunded from the forfeited tax sale fund upon the claim of the lessee, to be audited and
7.19 allowed by the county board as in case of other claims against the county.

7.20 (e) As directed by the county board, the county auditor may lease tax-forfeited land to
7.21 individuals, corporations, or organized subdivisions of the state at public or private sale, at
7.22 the prices and under the terms as the county board may prescribe, for the purpose of taking
7.23 and removing for use for road construction and other purposes tax-forfeited stockpiled
7.24 iron-bearing material. The county auditor must determine that the material is needed and
7.25 suitable for use in the construction or maintenance of a road, tailings basin, settling basin,
7.26 dike, dam, bank fill, or other works on public or private property, and that the use would
7.27 be in the best interests of the public. No lease shall exceed ten years. The use of a stockpile
7.28 for these purposes must first be approved by the commissioner of natural resources. The
7.29 request shall be deemed approved unless the requesting county is notified to the contrary
7.30 by the commissioner of natural resources within six months after receipt of a request for
7.31 approval for use of a stockpile. Once use of a stockpile has been approved, the county may
7.32 continue to lease it for these purposes until approval is withdrawn by the commissioner of
7.33 natural resources.

7.34 (f) The county auditor, with the approval of the county board is authorized to grant
7.35 permits, licenses, and leases to tax-forfeited lands for the depositing of stripping, lean ores,

8.1 tailings, or waste products from mines or ore milling plants, or to use for facilities needed
8.2 to recover iron-bearing oxides from tailings basins or stockpiles, or for a buffer area needed
8.3 for a mining operation, upon the conditions and for the consideration and for the period of
8.4 time, not exceeding 25 years, as the county board may determine. The permits, licenses, or
8.5 leases are subject to approval by the commissioner of natural resources.

8.6 (g) Any person who removes any timber from tax-forfeited land before said timber has
8.7 been scaled and fully paid for as provided in this subdivision is guilty of a misdemeanor.

8.8 (h) The county auditor may, with the approval of the county board, and without first
8.9 offering at public sale, grant leases, for a term not exceeding 25 years, for the removal of
8.10 peat and for the production or removal of farm-grown closed-loop biomass as defined in
8.11 section 216B.2424, subdivision 1, or short-rotation woody crops from tax-forfeited lands
8.12 upon the terms and conditions as the county board may prescribe. Any lease for the removal
8.13 of peat, farm-grown closed-loop biomass, or short-rotation woody crops from tax-forfeited
8.14 lands must first be reviewed and approved by the commissioner of natural resources if the
8.15 lease covers 320 or more acres. No lease for the removal of peat, farm-grown closed-loop
8.16 biomass, or short-rotation woody crops shall be made by the county auditor pursuant to this
8.17 section without first holding a public hearing on the auditor's intention to lease. One printed
8.18 notice in a legal newspaper in the county at least ten days before the hearing, and posted
8.19 notice in the courthouse at least 20 days before the hearing shall be given of the hearing.

8.20 (i) Notwithstanding any provision of paragraph (c) to the contrary, the St. Louis County
8.21 auditor may, at the discretion of the county board, sell timber to the party who bids the
8.22 highest price for all the several kinds of timber, as provided for sales by the commissioner
8.23 of natural resources under section 90.14. Bids offered over and above the appraised price
8.24 need not be applied proportionately to the appraised price of each of the different species
8.25 of timber.

8.26 (j) In lieu of any payment or deposit required in paragraph (b), as directed by the county
8.27 board and under terms set by the county board, the county auditor may accept an irrevocable
8.28 bank letter of credit in the amount equal to the amount otherwise determined in paragraph
8.29 (b). If an irrevocable bank letter of credit is provided under this paragraph, at the written
8.30 request of the purchaser, the county may periodically allow the bank letter of credit to be
8.31 reduced by an amount proportionate to the value of timber that has been harvested and for
8.32 which the county has received payment. The remaining amount of the bank letter of credit
8.33 after a reduction under this paragraph must not be less than 20 percent of the value of the
8.34 timber purchased. If an irrevocable bank letter of credit or cash deposit is provided for the
8.35 down payment required in paragraph (b), and no cutting of timber has taken place on the

9.1 contract for which a letter of credit has been provided, the county may allow the transfer
 9.2 of the letter of credit to any other contract issued to the contract holder by the county under
 9.3 this chapter to which the contract holder requests in writing that it be credited.

9.4 (k) As directed by the county board, the county auditor may lease tax-forfeited land
 9.5 under the terms and conditions prescribed by the county board for the purposes of
 9.6 investigating, analyzing, and developing conservation easements that provide ecosystem
 9.7 services.

9.8 Sec. 6. Minnesota Statutes 2022, section 282.04, is amended by adding a subdivision to
 9.9 read:

9.10 Subd. 4b. **Conservation easements.** The county auditor, with prior review and
 9.11 consultation with the commissioner of natural resources and under the terms and conditions
 9.12 prescribed by the county board, including reversion in the event of nonuse, may convey
 9.13 conservation easements as defined in section 84C.01 on tax-forfeited land.

9.14 Sec. 7. **ADDITION TO STATE PARK.**

9.15 **[85.012] [Subd. 27.] Myre-Big Island State Park, Freeborn County.** The following
 9.16 area is added to Myre-Big Island State Park, Freeborn County: all that part of the Northeast
 9.17 Quarter of the Southeast Quarter of Section 11, Township 102 North, Range 21 West of the
 9.18 5th principal meridian, lying South of the Chicago, Milwaukee, St. Paul and Pacific Railway,
 9.19 and subject to road easement on the easterly side thereof.

9.20 Sec. 8. **DELETION FROM STATE FOREST.**

9.21 **[89.021] [Subd. 13.] Cloquet Valley State Forest.** The following areas are deleted from
 9.22 Cloquet Valley State Forest:

9.23 (1) those parts of St. Louis County in Township 52 North, Range 16 West, described as
 9.24 follows:

9.25 (i) Government Lots 1, 2, 3, 4, and 5 and the Southeast Quarter of the Southeast Quarter,
 9.26 Northeast Quarter of the Southwest Quarter, and Southwest Quarter of the Southwest Quarter,
 9.27 Section 21;

9.28 (ii) Government Lots 2, 3, 4, 5, 6, 7, 8, 9, and 10 and the Northeast Quarter of the

10.7 presently owned land that may be sold, assigned, or transferred in Government Lot 1, Section
10.8 27, said access road being measured 33 feet from each side of the centerline of that road
10.9 that is presently existing at various widths and running in a generally
10.10 southwesterly-northeasterly direction;
- 10.11 (ix) Government Lots 1 and 2, Section 28;
- 10.12 (x) Government Lots 1, 2, 3, and 5 and the Northeast Quarter of the Northeast Quarter
10.13 and Southwest Quarter of the Northeast Quarter, Section 29;
- 10.14 (xi) Government Lots 1, 2, 3, and 4, Section 31, reserving unto grantor and grantor's
10.15 successors and assigns a 66-foot-wide access road easement across said Government Lots
10.16 1, 2, and 3 for the purpose of access to grantor's or grantor's successor's or assign's land and
10.17 grantor's presently owned lands that may be sold, assigned, or transferred in Government
10.18 Lot 4, Section 29, said access road being measured 33 feet from each side of the centerline
10.19 of that road that is presently existing at various widths and running in a generally East-West
10.20 direction and any future extensions thereof as may be reasonably necessary to provide the
10.21 access contemplated herein;
- 10.22 (xii) Government Lots 5, 7, 8, and 9, Section 31;
- 10.23 (xiii) Government Lots 1 and 2, an undivided two-thirds interest in the Northeast Quarter
10.24 of the Northwest Quarter, an undivided two-thirds interest in the Southeast Quarter of the
10.25 Northwest Quarter, and an undivided two-thirds interest in the Southwest Quarter of the
10.26 Northwest Quarter, Section 32, reserving unto grantor and grantor's successors and assigns
10.27 an access road easement across the West 66 feet of the North 66 feet of said Government
10.28 Lot 1 for the purpose of access to grantor's or grantor's successor's or assign's land and
10.29 grantor's presently owned land that may be sold, assigned, or transferred in Government

 21.12 Range 27 West, Sherburne County, Minnesota, lying southerly of the following described
 21.13 line: commencing at a Minnesota Department of Conservation monument on the south line
 21.14 of the said North 595.50 feet; thence North 89 degrees 38 minutes 17 seconds West, bearing
 21.15 per plat of Eagle Lake Estates Boundary Registration, along said south line 71.28 feet to a

21.20 (d) The Department of Natural Resources has determined that the land is not needed for

21.25 (a) Notwithstanding Minnesota Statutes, sections 94.3495 and 193.36, the adjutant
 21.26 general of the Minnesota National Guard may, with the approval of the Land Exchange
 21.27 Board as required under the Minnesota Constitution, article XI, section 10, exchange the
 21.28 surplus land described in paragraph (b) for an equal amount of land owned by the city of
 21.29 Rosemount, regardless of a difference in market value.

21.30 (b) The land to be exchanged is within the city of Rosemount adjacent to a Minnesota
 21.31 National Guard field maintenance shop.
