1.5	Section 1. [145.665] VACCINE RECIPIENT BILL OF RIGHTS.
1.6	Subdivision 1. Purposes; public policy. The purposes of this section are to defend the
1.7	constitutional liberties of Minnesota residents, promote the provision of vaccine information
1.8	to vaccine recipients, ensure vaccines are provided only after the provision of informed
1.9	consent, and promote sound science. It is declared to be the public policy of this state to
1.10	protect the interests of each vaccine recipient by establishing a vaccine recipient bill of
1.11	rights that includes but is not limited to the rights specified in this section.
1.12	Subd. 2. Determination of individual's medical interest. An individual shall reserve
1.13	the right, at all times, to determine what is in the individual's own best medical interest
1.14	regarding obtaining or not obtaining vaccines without threat to the individual's livelihood,
1.15	ability to attend school, or freedom of movement.
1.16	Subd. 3. Disclosure of specific vaccine being administered. A health care provider
1.17	administering a vaccine must disclose to each vaccine recipient the specific vaccine being
1.18	administered to the recipient.
1.19	Subd. 4. Information about vaccines. Before consenting to a vaccine, an individual
1.20	must be given access to information about the vaccine being offered to allow the individual
1.21	to determine whether obtaining the vaccine is in the individual's medical interest. Vaccine
