7.2	(1) adopt the model Program Accreditation Standards for Postsecondary Education
7.3	Programs for Students with Intellectual Disabilities and the inclusive higher education
7.4	guiding principles as developed by the National Coordinating Center;
7.5	(2) provide a 25 percent match for the grant funds, either monetary or in-kind; and
7.6	(3) collaborate with the Office of Higher Education, the center, and key stakeholders in
7.7	the development of the inclusive higher education initiative.
7.8	Subd. 6. Grantee reporting. By August 1 and January 1 following a fiscal year in which
7.9	a grant was received and for five years thereafter, the grantee must submit a report to the
