1.5	Section 1. TUITION RELIEF GRANT PROGRAM FOR STUDENTS PURSUING
1.6	A DEGREE IN LAW ENFORCEMENT.
1.7	Subdivision 1. Establishment. The commissioner of the Office of Higher Education
1.8	shall establish and implement a time-limited tuition relief grant program for students pursuing
1.9	an associate degree in law enforcement to incentivize individuals to become peace officers.
1.10	Subd. 2. Eligibility. A student is eligible for a grant under this program if the student:
1.11	(1) is a resident student under Minnesota Statutes, section 136A.101, subdivision 8;
1.12	(2) is enrolled on or before September 1, 2028, in a professional police officer education
1.13	program as defined in Minnesota Statutes, section 626.84, subdivision 1, paragraph (g). For
1.14	purposes of this definition, postsecondary degree means an associate degree;
1.15	(3) completes and submits the Free Application for Federal Student Aid (FAFSA);
1.16	(4) applies for state and federal grants and scholarships for which the applicant may be
1.17	eligible; and

2.2	in the amount of the actual cost of tuition and fees at the student's institution of attendance,
2.3	less any federal Pell Grant received, any state grant for which the student is eligible, and
2.4	any other scholarships or grants awarded to the student. For purposes of this section, the
2.5	term fees is defined in Minnesota Statutes, section 136A.121, subdivision 6, paragraph (d).
2.6	(b) The annual grant may be awarded for no more than four semesters, or its equivalent,
