1.8	(b) "Inherent risks of livestock activities" means dangers or conditions that are an integral
1.9	part of livestock activities, including:
1.10	(1) the propensity of livestock to behave in ways that may result in death or injury to
1.11	persons on or around them, such as kicking, biting, bucking, or charging;
1.12	(2) the unpredictability of livestock's reaction to things like sound, sudden movement,
1.13	unfamiliar objects, persons, or other animals;
1.14	(3) natural hazards such as surface or subsurface conditions; or
1.15	(4) collisions with other livestock or objects.
1.16	(c) "Livestock" means cattle, sheep, swine, horses, ponies, donkeys, mules, hinnies,
