1.14 1.15	That the Senate recede from its amendment and that H. F. No. 936 be further amended as follows:
1.16	Delete everything after the enacting clause and insert:
1.17	"Section 1. Minnesota Statutes 2008, section 256.975, is amended by adding a
1.18	subdivision to read:
1.19	Subd. 10. Communities for a lifetime. (a) For purposes of this subdivision,
1.20	"communities for a lifetime" means partnerships of small cities, counties, municipalities,
1.21	statutory or home rule charter cities, or towns, whose citizens seek to affirmatively extend
1.22	to persons ages 65 and older the opportunities, supports, and services that will enable them
1.23	to continue to be contributing, civically engaged residents.
1.24	(b) The opportunities extended within a reasonable distance to senior residents by
1.25	communities for a lifetime must include, but not be limited to:
1.26	(1) the opportunity to contribute time and talents through volunteer community
1.27	service;
1.28	(2) the opportunity to participate in the paid workforce, with flexibility of hours
1.29	and scheduling;

2.18	(4) access to a comprehensive caregiver support system for family members and
2.19	volunteer caregivers, including:

3.1	(2) offer training and learning opportunities for businesses, civic groups, fire and
3.2	police personnel, and others frequently interacting with seniors on appropriate methods
