Subd. 3. Notice required. An owner, operator, or provider of interactive computer	
services who restricts a user's account or content must provide a written notice to the use	<u>er</u>
within 24 hours of taking the action. The notice must specify the authority and basis for the	<u>he</u>
restriction.	
Subd. 4. Private civil action authorized. (a) The following users of an interactive	
computer service may bring an action in district court seeking damages as provided in

Subd. 6. Attorney general. The attorney general is authorized to investigate alleged violations of this section and recover damages on behalf of users entitled to relief under the section, as well as injunctive relief on behalf of the state.

Subd. 7. Personal jurisdiction; venue. (a) As to any cause of action arising under the
section, the district court may exercise personal jurisdiction over a nonresident defendant
in the same manner as if the defendant were a person domiciled in this state if:
(1) the defendant makes the interactive computer service available to residents of this
state; or
(2) enters into agreements with residents of this state for the provision of interactive
computer services.
(b) A cause of action arising under this section may be brought in the county in which
the plaintiff resides.
Subd. 8. Good faith and fair dealing. In any terms of service or other agreement
governing the provision of interactive computer services to a user, an implied covenant of
good faith and fair dealing bars the owner, operator, or provider of interactive computer
services from restricting a user or a user's content as provided under subdivision 2.
Subd. 9. Construction with other law or agreement; exemption. (a) The remedies in
this section are cumulative and do not restrict any other remedy provided by law.
(b) Any agreement or provision in an agreement waiving or limiting the rights, remedie
and duties provided in this section is deemed void and against public policy.
(c) This section does not apply to interactive computer services with less than 10,000,00
users.
Subd. 10. Severability. If any provision of this section is found to be unconstitutional
or otherwise void, the remaining provisions of this act remain valid.
EFFECTIVE DATE. This section is effective July 1, 2023, and applies to causes of
