The Minnesota Health Care Workforce Council is 1.8 established to: (1) provide ongoing policy and program monitoring and coordination; (2) 1.9 gather and analyze health care workforce education and training, trends, changes in health 1.10 care delivery, practice, and financing; and (3) recommend appropriate public and private 1.11 sector efforts to address identified workforce needs. The council shall focus on health care 1.12 workforce supply, demand, and distribution; cultural competence and diversity in health 1.13 professions education; oral health, mental health, and primary care training and practice; 1.14 1.15 and data evaluation and analysis. The council shall collaborate with other workforce and educational planning entities. 1.16 1.17 Subd. 2. **Terms of public members.** The terms of members appointed under subdivision 3, paragraph (a), clauses (3) to (9), shall be four years. Comprehensive health care workforce plan.
