2.19 commercial nonliability policies shall collect a surcharge as provided in this paragraph.
2.20 Through June 30, 2013, the surcharge is equal to 0.65 percent of the gross premiums
2.21 and assessments, less return premiums, on direct business received by the company, or
2.22 by its agents for it, for homeowner's insurance policies, commercial fire policies, and
2.23 commercial nonliability insurance policies in this state, and beginning July 1, 2013, the
2.24 surcharge is reduced to 0.5 percent.

4.14 Sec. 6. **DISTRIBUTION OF FIRE SAFETY ACCOUNT.**

4.15 On June 30, 2012, any unallocated balance in the fire safety account under section
4.16 297I.06, subdivision 3, not to exceed \$4,500,000, is appropriated to the commissioner of
4.17 public safety for recommendations of the advisory committee under Minnesota Statutes,
4.18 section 299F.012, subdivision 2, for the Minnesota Board of Firefighter Training and
4.19 Education and for fire-related regional response team programs and other fire service
4.20 programs with potential for statewide impact. This is a onetime appropriation. By January
4.21 15, 2014, the commissioner should report to the chairs and ranking minority members
4.22 of the legislative committees with jurisdiction over the fire safety account regarding the
4.23 balances and uses of the account.
