The mode of course delivery must meet the needs of working professionals across 2.11 the state. 2.12 (b) Grant funds may be used: 2.13 2.14 (1) to offset up to 80 percent of the tuition and fee costs for course enrollees; (2) for books and instructional materials for course enrollees; and 2.15 (3) for program administration, including course development, assessing the need for 2.16 course offerings, participant recruitment, and outcome reporting. 2.17 (c) Grants shall be awarded for up to one year. A postsecondary institution may apply 2.18 for and receive more than one grant. Outcome report requirements. Grant recipients shall report on program 2.22 outcomes to the commissioner. The report must specify participant attendance, course 2.23 completion, and performance outcomes for each course offering. Reports must be submitted 2.24 at the conclusion of each course offering. 2.25 2.26 Subd. 5. **Report.** By February 1 of each year, the commissioner shall submit a report to the chairs and ranking minority members of the legislative committees with jurisdiction 2.27 over higher education finance regarding the grant recipients and their activities. The report 2.28 shall include information about instructors served, instructors' school sites and sponsoring 2.29 concurrent enrollment institutions, courses offered, postsecondary institution grant recipients, 2.30 and program expenditures.
