1.8	An insurer who provides insurance for limousines, defined in section 168.002,
1.9	subdivision 15, shall provide insurance in a minimum aggregate amount of \$300,000
1.10	\$1,500,000 per accident for each limousine covered.
1.11	EFFECTIVE DATE. This section is effective July 1, 2014, and applies to policies
1.12	issued or renewed on or after that date.
