BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [144.1504] COMPREHENSIVE HEALTH CARE WORKFORCE PLANNING.

Subdivision 1. Establishment. The Minnesota Health Care Workforce Council is established to: (1) provide ongoing policy and program monitoring and coordination; (2) gather and analyze health care workforce education and training, trends, changes in health care delivery, practice, and financing; and (3) recommend appropriate public and private sector efforts to address identified workforce needs. The council shall focus on health care workforce supply, demand, and distribution; cultural competence and diversity in health professions education; oral health, mental health, and primary care training and practice; and data evaluation and analysis. The council shall collaborate with other workforce and educational planning entities.

Subd. 2. Terms of public members. The terms of members appointed under subdivision 3, paragraph (a), clauses (3) to (9), shall be four years. Members may serve until their successors are appointed and qualify. If a successor is not appointed by the July 1 after the scheduled end of a member's term, the term of the member for whom a successor has not been appointed shall be extended until the first Monday in January four years after the scheduled end of the term.

Subd. 3. **Membership.** (a) The Minnesota Health Care Workforce Council shall consist of 29 members appointed as follows:

2.14	(7) one member appointed by the University of Minnesota;
2.15	(8) one member appointed by the Minnesota State Colleges and Universities system;
2.16	(9) one member appointed by the Minnesota Private College Council;
2.17	(10) one member appointed by HealthForce Minnesota;
2.18	(11) one member appointed by the governor representing a nonphysician health care
2.19	provider, such as a physician assistant or an advanced practice registered nurse;
2.20	(12) the commissioner of human services or a designee;
2.21	(13) the commissioner of employment and economic development or a designee;
2.22	(14) the commissioner of education or a designee;
2.23	(15) one member representing the governor's office;
2.24	(16) the commissioner of health or a designee; and
2.25	(17) the commissioner of the Office of Higher Education or a designee.
2.26	(b) Appointments must be made by September 1, 2016. The commissioner of health
2.27	shall convene the first meeting no later than October 1, 2016. Members of the council
2.28	shall elect a chair at the first meeting.
2.29	(c) Except for section 15.059, subdivisions 2 and 3, section 15.059 shall apply
2.30	to the council and to all council member appointments, except those members who
2.31	are commissioners or their designees. The members of the council shall receive no
2.32	compensation other than reimbursement for expenses. Notwithstanding section 15.059,
2.33	subdivision 6, the council shall not expire.
2.34	Subd. 4. Comprehensive health care workforce plan. (a) By September 30, 2017,
