1.7	Up to \$ in fiscal year 2024 is appropriated from the general fund to the commissioner
1.8	of agriculture for Dairy Assistance, Investment, Relief Initiative (DAIRI) grants to Minnesota
1.9	dairy farmers who enroll in coverage under a federal dairy risk protection program and
1.10	produced no more than 25,000,000 pounds of milk in 2022. The commissioner must award
1.11	DAIRI grants based on the amount of milk produced in 2022, up to 5,000,000 pounds per
