1.8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.9	Section 1. Minnesota Statutes 2022, section 84.788, subdivision 5, is amended to read:
1.10	Subd. 5. Report of ownership transfers; fee. (a) Application for transfer of ownership
1.11	of an off-highway motorcycle registered under this section must be made to the commissioner
1.12	within 15 days of the date of transfer.
1.13	(b) An application for transfer must be executed by the registered current owner and the
1.14	purchaser using a bill of sale that includes the vehicle serial number.
1.15	(c) The purchaser is subject to the penalties imposed by section 84.774 if the purchaser

temporary permit must contain the dealer's identification number and phone number. Each
retail dealer shall submit completed registration and fees to the deputy registrar at least once
a week. No fee may be charged by a dealer to a purchaser for providing the temporary
permit.

(c) Upon receipt of the application and the appropriate fee, the commissioner or deputy 2.6 registrar shall issue to the applicant, or provide to the dealer, an assigned registration number 2.7 or a commissioner or deputy registrar temporary 21-day permit. The registration number 2.8 must be printed on a registration decal issued by the commissioner or a deputy registrar. 2.9 Once issued, the registration number decal must be affixed to the snowmobile in a clearly 2.10 visible and permanent manner for enforcement purposes as the commissioner of natural 2.11 resources shall prescribe according to subdivision 3b. A dealer subject to paragraph (b) 2.12 shall provide the registration materials or temporary permit to the purchaser within the 2.13 temporary 21-day permit period. The registration is not valid unless signed by at least one 2.14 owner. 2.15

(d) Each deputy registrar of motor vehicles acting pursuant to section 168.33 shall also
be a deputy registrar of snowmobiles. The commissioner of natural resources in agreement
with the commissioner of public safety may prescribe the accounting and procedural
requirements necessary to ensure efficient handling of registrations and registration fees.
Deputy registrars shall strictly comply with these accounting and procedural requirements.

(e) In addition to other fees prescribed by law, an issuing fee of \$4.50 is charged for
each snowmobile registration renewal, duplicate or replacement registration card, and
replacement decal, and an issuing fee of \$7 is charged for each snowmobile registration and
registration transfer issued by:

4.2	Subdivision 1. Required rules, fees, and reports. (a) With a view of achieving maximum
4.3	use of snowmobiles consistent with protection of the environment the commissioner of
4.4	natural resources shall adopt rules in the manner provided by chapter 14, for the following
4.5	purposes:

The 4.20 commissioner shall collect a fee, to include a \$1 issuing fee for licensing agents, for issuing 4.21 a duplicate snowmobile safety certificate. The commissioner shall establish both fees in a 4.22 manner that neither significantly overrecovers nor underrecovers costs, including overhead 4.23 costs, involved in providing the services. The fees are not subject to the rulemaking provisions 4.24 of chapter 14, and section 14.386 does not apply. The fees may be established by the 4.25 commissioner notwithstanding section 16A.1283. The fees, except for the issuing fee for 4.26 4.27 licensing agents under this subdivision, shall be deposited in the snowmobile trails and enforcement account in the natural resources fund and the amount thereof, except for the 4.28 electronic licensing system commission established by the commissioner under section 4.29 84.027, subdivision 15, and issuing fees collected by the commissioner, is appropriated 4.30 annually to the Enforcement Division of the Department of Natural Resources for the 4.31 administration of such administering the programs. No person shall operate a snowmobile within the right-of-way of 5.20 any trunk, county state-aid, or county highway between the hours of one-half hour after 5.21 sunset to one-half hour before sunrise, except on the right-hand side of such right-of-way 5.22 and in the same direction as the highway traffic on the nearest lane of the roadway adjacent 5.23 thereto. No snowmobile shall be operated at any time within the right-of-way of any interstate 5.24 highway or freeway within this state. 5.25

(b) Notwithstanding any provision of paragraph (a) to the contrary:

(1) under conditions prescribed by the commissioner of transportation, the commissioner
of transportation may allow two-way operation of snowmobiles on either side of the trunk
highway right-of-way where the commissioner of transportation determines that two-way
operation will not endanger users of the trunk highway or riders of the snowmobiles using
the trail;

(2) under conditions prescribed by a local road authority as defined in section 160.02,
subdivision 25, the road authority may allow two-way operation of snowmobiles on either
side of the right-of-way of a street or highway under the road authority's jurisdiction, where

the road authority determines that two-way operation will not endanger users of the street or highway or riders of the snowmobiles using the trail;
(3) the commissioner of transportation under clause (1) and the local road authority under clause (2) shall notify the commissioner of natural resources and the local law enforcement agencies responsible for the streets or highways of the locations of two-way snowmobile trails authorized under this paragraph; and
(4) two-way snowmobile trails authorized under this paragraph shall be posted for two-way operation at the authorized locations.
(c) A snowmobile may make a direct crossing of a street or highway at any hour of the day provided:
(1) the crossing is made at an angle of approximately 90 degrees to the direction of the highway and at a place where no obstruction prevents a quick and safe crossing;

6.13 (2) the snowmobile is brought to a complete stop before crossing the shoulder or main
6.14 traveled way of the highway;

6.15 (3) the driver yields the right-of-way to all oncoming traffic which constitutes an6.16 immediate hazard;

6.17 (4) in crossing a divided highway, the crossing is made only at an intersection of such
6.18 highway with another public street or highway or at a safe location approved by the road
6.19 <u>authority;</u>

6.20 (5) if the crossing is made between the hours of one-half hour after sunset to one-half
6.21 hour before sunrise or in conditions of reduced visibility, only if both front and rear lights
6.22 are on; and

6.23 (6) a snowmobile may be operated upon a bridge, other than a bridge that is part of the
6.24 main traveled lanes of an interstate highway, when required for the purpose of avoiding
6.25 obstructions to travel when no other method of avoidance is possible; provided the
6.26 snowmobile is operated in the extreme right-hand lane, the entrance to the roadway is made
6.27 within 100 feet of the bridge and the crossing is made without undue delay.

(d) No snowmobile shall be operated upon a public street or highway unless it is equipped
with at least one headlamp, one tail lamp, each of minimum candlepower as prescribed by
rules of the commissioner, reflector material of a minimum area of 16 square inches mounted
on each side forward of the handle bars, and with brakes each of which shall conform to
standards prescribed by rule of the commissioner pursuant to the authority vested in the

#### APPENDIX Repealed Minnesota Rules: S0031-1

### 6100.5000 SNOWMOBILE REGISTRATION AND DISPLAY OF NUMBERS.

Subp. 3. Affixation of number. The registration number of the snowmobile, shown on the registration certificate, shall be affixed to the snowmobile and maintained in a clear, legible manner. On all machines made after June 30, 1972, and sold in Minnesota, such registration number shall be affixed in the space provided therefor in accordance with part 6100.5700, subpart 4. On all other machines it shall be affixed on each side of the cowling on the upper half of the machine, as follows.

Subp. 4. **Description of decal or number; lost or destroyed number or decal.** All letters and numbers shall be of a color which will contrast with the surface to which applied, and shall be at least three inches high and three-eighths inch stroke. When any previously affixed registration number or decal is destroyed or lost, a duplicate shall be affixed in the manner shown above. The registration number shall remain the same if renewed by July 1 following the expiration date.

Subp. 5. **General prohibition.** No person shall operate or transport, and no person shall permit the operation of, a snowmobile within this state which does not have its registration number and unexpired decal affixed in the form and manner required by this part, unless the owner is exempted from the registration requirements of this state by Minnesota Statutes, section 84.82.

### 6100.5700 REQUIRED EQUIPMENT.

Subp. 4. **Snowmobile registration number affixation.** All snowmobiles made after June 30, 1972, and sold in Minnesota, shall be designed and made to provide an area on which to affix the snowmobile registration number at the following location and of the following dimensions:

A. A clear area shall be provided on each side of the cowling or pan with the minimum size of 3-1/2 inches vertical by 11 inches horizontal.

B. It shall be a minimum of 12 inches from the ground when the machine is resting on a hard surface.
