- (b)(1) "Advertising" or "advertisement" means any of the following:
- (i) any written or printed communication made for the purpose of soliciting business for veterans benefits appeal services, including but not limited to a brochure, letter, pamphlet, newspaper, telephone listing, periodical, or other writing;
- (ii) any directory listing caused or permitted by a person and made available by that person indicating that veterans benefits appeal services are being offered; or

(iii) any radio, television, computer network, or similar airwave or electronic 3.1 transmission that solicits business for or promotes a person offering veterans benefits 3.2 appeal services. 3.3 (2) "Advertising" or "advertisement" does not include any of the following: 3.4 (i) any printing or writing used on buildings, uniforms, or badges, where the purpose 3.5 of the writing is for identification; 3.6 (ii) any printing or writing in a memorandum or other communication used in the 3.7 ordinary course of business where the sole purpose of the writing is other than soliciting 3.8 business for veterans benefits appeal services. 3.9 (c) "Veterans benefits appeal services" means services that a veteran might 3.10 reasonably require in order to appeal a denial of federal or state veterans benefits, 3.11 3.12 including but not limited to denials of disability, limited income, home loan, insurance, education and training, burial and memorial, and dependent and survivor benefits. 3.13 (d) "Veterans benefits services" means services that a veteran or a family member of 3.14 3.15 a veteran might reasonably use in order to obtain federal, state, or county veterans benefits. Veterans benefits services disclosure requirements. A person who 3.22 3.23 provides veterans benefits services in exchange for compensation shall provide a written disclosure statement to each client or prospective client. Civil penalties 3.30 shall be assessed by the district court in an action initiated by the attorney general.
