BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. PLANNING GROUP TO DECRIMINALIZE MENTAL ILLNESS. 1.5 Subdivision 1. **Establishment.** A planning group is established to conduct a community 1.6 needs assessment and advise the legislature on the legal and policy issues associated with 1.7 the decriminalization of mental illness. The group shall assess best practices for law 1.8 enforcement, barriers in accessing courts, and disparities in correctional settings when 1.9 responding to persons with mental illness. 1.10 Subd. 2. Duties. The planning group shall study and review the barriers, best practices, 1.11 and strategies for addressing disparities in the criminal justice system and barriers to 1.12 accessing the courts for persons with mental illness, including: 1.13 (1) training protocols and technical assistance for law enforcement; 1.14 (2) incarceration rates and alternatives; 1.15 (3) sentencing; 1.16 (4) accessibility barriers and access to correctional programming; 1.17 (5) probation, parole, and reentry; 1.18 (6) competency; 1.19 (7) access to health care; 1.20
