1.6	Section 1. [63A.01] DEFINITIONS.
1.7	(a) As used in this chapter, the following terms have the meanings given.
1.8	(b) "Armed forces of the United States" means members of the National Guard and
1.9	Reserves.
1.10	(c) "Child" means a person who is:
1.11	(1) under 18 years of age, or 18 years of age or older and incapable of self-care as a
1.12	result of a mental or physical disability; and
1.13	(2) a biological, adopted, or foster son or daughter; a stepson or stepdaughter; a legal
1.14	ward; a son or daughter of a domestic partner; or a son or daughter of a person to whom the
1.15	employee stands in loco parentis.
1.16	(d) "Family leave" means leave taken by an employee from work for a reason specified
1.17	in section 63A.03.
1.18	(e) "Family member" means a child, spouse, parent, or grandparent, as defined in this
