1.7	Section 1. Minnesota Statutes 2020, section 244.09, subdivision 2, is amended to read:
1.8	Subd. 2. Members. The Sentencing Guidelines Commission shall consist of the
1.9	following:
1.10	(1) the chief justice of the supreme court or a designee;
1.11	(2) one judge of the court of appeals, appointed by the chief justice of the supreme court;
1.12	(3) one district court judge appointed by the chief justice of the supreme court;
1.13	(4) one public defender appointed by the governor upon recommendation of the state
1.14	public defender;
1.15	(5) one county attorney appointed by the governor upon recommendation of the board
1.16	of directors of the Minnesota County Attorneys Association;
1.17	(6) the commissioner of corrections or a designee;
1.18	(7) one peace officer as defined in section 626.84 appointed by the governor;
1.19	(8) one probation officer or parole officer appointed by the governor; and

When an appointing authority selects individuals for membership on the commission,

the authority shall make reasonable efforts to appoint qualified members of protected groups, 2.2 as defined in section 43A.02, subdivision 33. 2.3 One of the members shall be designated by the governor as chair of the commission. 2.4 The appointments of members described in clauses (2), (3), (4), (5), (7), (8), and (9) are 2.5 to be made with the advice and consent of the senate. (a) The Minnesota Sentencing Guidelines Commission shall adopt further rules regulating 2.21 how the commission's hearings are to be conducted. These rules must ensure that proper 2.22 notice of at least seven days is provided to commission members and the public regarding 2.23 the time and place for a meeting. This notice must include any proposed amendments or 2.24 modifications to the guidelines to be discussed and a detailed agenda that distinguishes 2.25 between informational items, discussion items, and action items. The rules must prohibit 2.26 items not included as action items from being acted on at that hearing. Further, the rules 2.27 must prohibit a vote on any proposal to amend or modify the guidelines during the same 2.28 meeting that it was first presented. In addition, the rules must prohibit the final adoption of 2.29 a proposed modification to the guidelines that was forwarded for a public hearing and that 2.30 was amended in any substantive way at or following the public hearing, unless another 2.31 public hearing is held on the revised language. 2.32
