1.6	Section 1. VETERANS HOME; FILLMORE COUNTY.
1.7	Subdivision 1. Short title. This section may be cited as the "Minnesota Veterans
1.8	and Quality of Life Act."
1.9	Subd. 2. Appropriation. \$10,000,000 is appropriated from the bond proceeds fund
1.10	to the commissioner of administration to design, construct, furnish, and equip a veterans
1.11	home in Fillmore County to provide a continuum of care, including skilled nursing care,
1.12	to Minnesota veterans.
1.13	Subd. 3. Veterans home established. The commissioner of veterans affairs may
