1.5	Section 1. Minnesota Statutes 2012, section 297B.03, is amended to read:
1.6	297B.03 EXEMPTIONS.
1.7	There is specifically exempted from the provisions of this chapter and from
1.8	computation of the amount of tax imposed by it the following:
1.9	(1) purchase or use, including use under a lease purchase agreement or installment
1.10	sales contract made pursuant to section 465.71, of any motor vehicle by the United States
1.11	and its agencies and instrumentalities and by any person described in and subject to the
1.12	conditions provided in section 297A.67, subdivision 11;
1.13	(2) purchase or use of any motor vehicle by any person who was a resident of

Subdivision 1. Refund to purchaser. If a town, county, statutory or home rule 3.22 charter city, or any of their instrumentalities paid sales tax on a road maintenance vehicle 3.23 exempted under Minnesota Statutes, section 297B.03, clause (10), and purchased after 3.24 December 31, 2013, but before July 1, 2014, the purchaser may apply directly to the 3.25 commissioner of revenue for a refund. The application for refund must be on forms 3.26 prescribed by the commissioner of revenue and must include sufficient information to allow 3.27 verification of the tax paid. All applications for refund must be filed by December 31, 2014. 3.28 Subd. 2. Interest paid. Interest must be paid on the refund at the rate specified in 3.29 Minnesota Statutes, section 270C.405, beginning 90 days after the refund application is 3.30 filed with the commissioner of revenue. 3.31 Subd. 3. Appropriation; allocation. Payment of a refund pursuant to this section 3.32 must be made out of the general and highway user funds and accounts in the same 3.33 proportion provided for deposit of proceeds from the sales tax on motor vehicles under 3.34
