1.8	ELECTRONIC ROSTER STUDY
1.9	Section 1. ELECTRONIC ROSTER STUDY.
1.10	Subdivision 1. Established. A study is established to explore the use of electronic
1.11	rosters in conducting elections. Jurisdictions participating in the study may use electronic
1.12	rosters to process election day registration, to verify the registration status of preregistered
1.13	voters, or both. The study shall apply to the 2014 state general election. The standards for
1.14	conducting the study are provided in this section.
1.15	Subd. 2. Participating municipalities. Precincts located in Baxter, Brainerd,
