1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:			
1.5	Section 1. Minnesota Statutes 2014, section 240.23, is amended to read:			
1.6	240.23 RULEMAKING AUTHORITY.			
1.7	The commission has the authority, in addition to all other rulemaking authority			
1.8	granted elsewhere in this chapter to promulgate rules governing:			
1.9	(a) the conduct of horse races held at licensed racetracks in Minnesota, including but			
1.10	not limited to the rules of racing, standards of entry, operation of claiming races, filing and			
1.11	handling of objections, carrying of weights, and declaration of official results;			
1.12	(b) wire wired and wireless communications between the premises of a licensed			
1.13	racetrack and any place outside the premises;			
1.14	(c) information on horse races which is sold on the premises of a licensed racetrack;			
1.15	(d) liability insurance which it may require of all class A, class B, and class D			
1.16	licensees;			
1.17	(e) the auditing of the books and records of a licensee by an auditor employed			
1.18	or appointed by the commission;			
1.19	(f) emergency action plans maintained by licensed racetracks and their periodic			
1.20	review;			
1.21	(g) safety, security, and sanitation of stabling facilities at licensed racetracks;			
1.22	(h) entry fees and other funds received by a licensee in the course of conducting			
1.23	racing which the commission determines must be placed in escrow accounts;
