An individual selling exempt foods under this section is 1.7 limited to total sales with gross receipts of \$78,000 \$85,000 or less in a calendar year. 1.8 Sec. 2. Minnesota Statutes 2022, section 28A.152, subdivision 4, is amended to read: 1.9 Subd. 4. Registration. An individual who prepares and sells exempt food under 1.10 subdivision 1 must register annually with the commissioner. The commissioner shall register 1.11 an individual within 30 days of submitting a complete registration to the commissioner. A 1.12 registration shall be deemed accepted after 30 days following an individual's complete 1.13 registration to the commissioner. The annual registration fee is \$50.
