.10	cooperation with colleges and universities that offer board-approved teacher preparation
.11	programs and the Office of Higher Education under section 136A.01, annually must
.12	collect valid, reliable, and timely data for comparing the efficacy of the state's teacher
.13	preparation programs. Each year, by June 1, the Board of Teaching, after consulting
.14	with the Office of Higher Education and interested stakeholders such as the Minnesota
.15	Association of Colleges for Teacher Education, must publish summary data on programs'
