1.7	Subdivision 1. Misdemeanor offenses. Whoever does the following is guilty of a
1.8	misdemeanor:
1.9	(1) refuses to relinquish immediately a coin-operated telephone or a telephone line
1.10	consisting of two or more stations when informed that the line is needed to make an
1.11	emergency call;
1.12	(2) secures a relinquishment of a coin-operated telephone or a telephone line consisting
1.13	of two or more stations by falsely stating that the line is needed for an emergency;
1.14	(3) publishes telephone directories to be used for telephones or telephone lines and the
1.15	directories do not contain a copy of this section;
1.16	(4) makes a call for emergency police, fire, medical, or ambulance service, knowing
1.17	that no police, fire, or medical emergency exists;
