1.6	(a) No later than the 2017-2018 school year, the Board of Trustees of the Minnesota
1.7	State Colleges and Universities must design and implement a plan to address remedial
1.8	education issues for state college and university students. The plan must include the
1.9	following:
1.10	(1) an alternative method of admission that does not require completion of the ACT
1.11	or other standardized testing, for otherwise qualified students who experience difficulty
1.12	completing standardized tests but who are able to demonstrate a likelihood of success in a
1.13	college or university setting by other means;
1.14	(2) replacement or minimization of remedial coursework, in favor of corequisite
1.15	courses in which students earn academic credit toward a certificate, diploma, or degree,
1.16	and have the opportunity, if necessary, to receive supplemental instruction from a remedia

1.18	(3) an increase in the number of counselors available on each campus to assist
