1.6	Subdivision 1. Service credit purchase. (a) Notwithstanding Minnesota Statutes, section
1.7	353.27, subdivision 12, an eligible person described in paragraph (b) is entitled to purchase
1.8	allowable service in the public employees police and fire retirement plan under Minnesota
