1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2014, section 297E.02, subdivision 6, is amended to read: 1.5 Subd. 6. Combined net receipts tax. (a) In addition to the taxes imposed under 1.6 subdivision 1, a tax is imposed on the combined receipts of the organization. As used 1.7 in this section, "combined net receipts" is the sum of the organization's gross receipts 1.8 from lawful gambling less gross receipts directly derived from the conduct of paper 19 bingo, raffles, and paddlewheels, as defined in section 297E.01, subdivision 8, and less 1.10 the net prizes actually paid, other than prizes actually paid for paper bingo, raffles, and 1.11 paddlewheels, for the fiscal year. The combined net receipts of an organization are subject 1.12 to a tax computed according to the following schedule: 1.13

(b) On or before April 1, 2016, the commissioner shall estimate the total amount of
revenue, including interest and penalties, that will be collected for fiscal year 2016 from
taxes imposed under this chapter. If the amount estimated by the commissioner equals

or exceeds \$94,800,000, the commissioner shall certify that effective July 1, 2016, the 2.1

rates under this paragraph apply in lieu of the rates under paragraph (a) and shall publish a 2.2

notice to that effect in the State Register and notify each taxpayer by June 1, 2016. If the 2.3

rates under this section apply, the combined net receipts of an organization are subject to a 2.4

under this section. For purposes of this paragraph, a sports-themed tipboard means a 2.18

(d) Organizations that conduct lawful gambling in a location where the primary 2.21

business is bingo are exempt from taxation under this subdivision. 2.22
