1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. CONSTITUTIONAL AMENDMENT PROPOSED.
1.6	An amendment to the Minnesota Constitution is proposed to the people. If the
1.7	amendment is adopted, a section shall be added to article XIII to read:
1.8	Sec. 13. To preserve the freedom of Minnesotans to choose health care and health
1.9	care coverage:
1.10	(1) no federal, state, or local law or rule shall compel, directly or indirectly, any
1.11	person, employer, or health care provider to participate in a health system;
1.12	(2) no federal, state, or local law or rule shall prohibit the purchase or sale of health
1.13	care or health insurance; and
1.14	(3) no federal, state, or local law or rule shall impose a penalty or fine for the sale or
1.15	purchase of health care or health insurance.
1.16	This section does not affect laws or rules in effect as of March 19, 2010; affect
1.17	which services a health care provider or hospital is required to perform or provide; affect
1.18	terms and conditions of government employment; or affect any laws calculated to deter
1.19	fraud or punish wrongdoing in the health care industry. This section does not affect the
1.20	ability of the state to participate in and administer medical assistance, MinnesotaCare,
1.21	or other state public health care programs, or to receive any available federal financial
1.22	participation for those programs.

2.5	(3) "penalty or fine" means any civil or criminal penalty or fine, tax, salary, or wage
2.6	withholding or surcharge or any named fee established by law or rule by a government
2.7	agency that is used to punish or discourage the exercise of rights protected under this

2.9	Sec. 2. SUBMISSION TO VOTERS.
2.10	The proposed amendment must be submitted to the people at the 2012 general
2.11	election. The question submitted must be:
2.12	"Shall the Minnesota Constitution be amended to state that to preserve the freedom
2.13	of Minnesotans to choose health care and health care coverage:
2.14	(1) no federal, state, or local law or rule shall compel, directly or indirectly, any

2.16	(2) no federal, state, or local law or rule shall prohibit the purchase or sale of health

2.18	(3) no federal, state, or local law or rule shall impose a penalty or fine for the sale or
