1.7	Section 1. Minnesota Statutes 2015 Supplement, section 144A.75, subdivision 13,
1.8	is amended to read:
1.9	Subd. 13. Residential hospice facility. (a) "Residential hospice facility" means a
1.10	facility that resembles a single-family home modified to address life safety, accessibility,
1.11	and care needs, located in a residential area that directly provides 24-hour residential
1.12	and support services in a home-like setting for hospice patients as an integral part of the
1.13	continuum of home care provided by a hospice; that provides care for hospice patients,
1.14	or for children who need respite care or palliative care due to a condition suggesting a
1.15	shortened life expectancy; and that houses:
1.16	(1) no more than eight hospice patients or children who need respite care or
1.17	palliative care; or
1.18	(2) at least nine and no more than 12 hospice patients or children who need respite
1.19	care or palliative care, with the approval of the local governing authority, notwithstanding
1.20	section 462.357, subdivision 8.
1.21	(b) Residential hospice facility also means a facility that directly provides 24-hour
1.22	residential and support services for hospice patients and that:
1.23	(1) houses no more than 21 hospice patients;
1.24	(2) meets hospice certification regulations adopted pursuant to title XVIII of the
1.25	federal Social Security Act, United States Code, title 42, section 1395, et seq.; and

- 2.5 <u>Subd. 13a.</u> **Respite care.** "Respite care" means short-term care in an inpatient facility
- 2.6 <u>such as a residential hospice facility, when necessary to relieve the hospice patient's family;</u>
- 2.7 <u>the family of a child with a condition suggesting a shortened life expectancy; or other</u>
- 2.8 persons caring for the patient or child. Respite care may be provided on an occasional basis.
