1.5	Section 1. Laws 2022, chapter 42, section 2, is amended to read:
1.6	Sec. 2. APPROPRIATION; ALS RESEARCH.
1.7	(a) \$20,000,000 in fiscal year 2023 is and \$ in fiscal year 2024 are appropriated
1.8	from the general fund to the commissioner of the Office of Higher Education to award
1.9	competitive grants to applicants for research into amyotrophic lateral sclerosis (ALS). The
1.10	commissioner may work with the Minnesota Department of Health to administer the grant
1.11	program, including identifying clinical and translational research and innovations, developing
1.12	outcomes and objectives with the goal of bettering the lives of individuals with ALS and
1.13	finding a cure for the disease, and application review and grant recipient selection. Not more
1.14	than \$400,000 may be used by the commissioner to administer the grant program.
1.15	(b) Grants shall be awarded to support clinical and translational research related to ALS.
1.16	Research topics may include but are not limited to environmental factors, disease
