1.11	Subd. 2. Authorization. (a) The agency may issue up to \$30,000,000 in aggregate
1.12	principal amount of housing infrastructure bonds in one or more series to which the payment
1.13	made under this section may be pledged. The housing infrastructure bonds authorized in
