1.1 A bill for an act

relating to human services; requiring commissioner of human services to seek a federal waiver to establish a work and community engagement requirement for certain medical assistance enrollees.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. MEDICAL ASSISTANCE WORK AND COMMUNITY ENGAGEMENT REQUIREMENT FOR ABLE-BODIED INDIVIDUALS.

Subdivision 1. Waiver request. (a) By October 1, 2018, the commissioner of human services shall apply to the Centers for Medicare and Medicaid Services for a section 1115 waiver to allow the state to implement a medical assistance work and community engagement requirement for able-bodied adults who meet the definition of "qualified individual," in order to improve enrollee health and well-being. The waiver proposal must meet the criteria specified in this section, be consistent with the work requirements of the Supplemental Nutrition Assistance Program (SNAP) as specified in Code of Federal Regulations, title 7, parts 273.24 and 273.7, and be consistent with the guidance issued by the Centers for Medicare and Medicaid Services on January 11, 2018, Opportunities to Promote Work and Community Engagement Among Medicaid Beneficiaries.

(b) The commissioner, at least 60 days prior to submittal of the waiver application to the federal government, shall report to the chairs and ranking minority members of the legislative committees with jurisdiction over health and human services policy and finance, on the specific strategies, criteria, requirements, and procedures the commissioner proposes to use to implement subdivision 3, paragraphs (a) and (b), and to comply with subdivision 4. The commissioner shall make the report available to the public on the agency's Web site.
