1.7	The public policy of this state is to:
1.8	(1) ensure that each child has frequent and substantial contact with the child's parents,
1.9	as long as the child's parents have shown the ability to act in the best interests of the child;
1.10	(2) ensure that parents and caregivers provide a safe and nurturing environment for each
1.11	child; and
1.12	(3) encourage parents to share the rights and duties of raising their child.

In determining custody, the court must consider the best interests of each child and must not prefer one parent over the other solely on the basis of the gender of the parent. (3) The court shall consider both parents as having the capacity to develop and sustain nurturing relationships with their children unless there are substantial reasons to believe otherwise. In assessing whether parents are capable of sustaining nurturing relationships with their children, the court shall recognize that there are many ways that parents can respond to a child's needs with sensitivity and provide the child love and guidance, and these may differ between parents and among cultures. (4) The court shall not consider conduct of a party that does not affect the party's relationship with the child.
