1.8	Section 1. Minnesota Statutes 2018, section 204B.135, subdivision 2, is amended to read:
1.9	Subd. 2. Other election districts. (a) For purposes of this subdivision, "local government
1.10	election district" means a county district, park and recreation district, school district, or soil
1.11	and water conservation district. Local government election districts, other than city wards
1.12	covered by subdivision 1, may not only be redistricted until as follows:
1.13	(1) except as provided in clause (2), local government election districts may be redistricted
1.14	(i) after precinct boundaries are reestablished under section 204B.14, subdivision 3, paragraph
1.15	(c). Election districts covered by this subdivision must be redistricted; and (ii) within 80

Subd. 3. Voters rights. (a) An eligible voter may apply to the district court for either a
writ of mandamus requiring the redistricting of wards or local government election districts
or to revise any plan adopted by the governing body responsible for redistricting of wards
or local government election districts.

(b) If a city adopts a ward redistricting plan at least 19 weeks before the primary in a 2.6 year ending in two, an application for revision of the plan that seeks to affect elections held 2.7 in the year ending in two must be filed with the district court within three weeks but no later 2.8 than 18 weeks before the state primary election in the year ending in two, notwithstanding 2.9 any charter provision. application for the revision of the plan must be filed with the district court no later than one
week after that plan has been adopted, notwithstanding any charter provision.

(c) (d) If a plan for redistricting of a local government election district is adopted at least 2.22 15 weeks before the state primary election in a year ending in two, an application for revision 2.23 of the plan that seeks to affect elections held in the year ending in two must be filed with 2.24 the district court within three weeks but no later than 14 weeks before the state primary 2.25 2.26 election in the year ending in two. The municipal general election in each city shall be 3.6 held on the first Tuesday after the first Monday in November in every even-numbered year. 3.7 Notwithstanding any provision of law to the contrary and subject to the provisions of this 3.8 section, the governing body of a city may, by ordinance passed at a regular meeting held at 3.9 least 180 calendar days before the first day to file for candidacy in the next municipal 3.10 election, decide to hold the election on the first Tuesday after the first Monday in November 3.11 in either an even- or odd-numbered year. A city may hold elections in either the 3.12 even-numbered year or the odd-numbered year, but not both. When a city changes its 3.13 elections from one year to another, and does not provide for the expiration of terms by 3.14 ordinance, the term of an incumbent expiring at a time when no municipal election is held 3.15 in the months immediately prior to expiration is extended until the date for taking office 3.16 following the next scheduled municipal election. If the change results in having three council 3.17 members to be elected at a succeeding election, the two individuals receiving the highest 3.18 vote shall serve for terms of four years and the individual receiving the third highest number 3.19 of votes shall serve for a term of two years.
