"Wireless communications device" means 17 (1) a cellular phone, or (2) a portable electronic device that is capable of receiving and 18 transmitting data, including but not limited to text messages and e-mail, without an access 19 line for service. A wireless communications device does not include a device or feature that 1.10 is permanently affixed to physically integrated into the vehicle, or including a global 1.11 positioning system or navigation system when the system is used exclusively for navigation 1.12 purposes. 1.13 1.14 Sec. 2. 169.475 USE OF WIRELESS COMMUNICATIONS DEVICE.

designed or intended to be transmitted between physical devices. An electronic message

includes, but is not limited to;: e-mail;; a text message;; an instant message;; a command or

request to access a World Wide web page, or; a voice mail message; a transmitted image;

transmitted audio content; transmitted video content, including through video calling; and

- (c) "Voice-activated or hands-free mode" means an attachment, an accessory, a wirelessly paired or tethered capability, or a built-in capability of a wireless communications device or a motor vehicle that allows a person to use a feature or software application without either hand, except for one touch activation or deactivation of the feature or software application. A feature or software application includes but is not limited to text messaging and phone calling.
- (d) For purposes of this section, a motor vehicle is not in motion or a part of traffic if the vehicle is lawfully stopped, is in a location that is not designed or ordinarily used for vehicular travel, and is not obstructing traffic.
- (e) For purposes of subdivision 2, paragraph (a), "using" includes but is not limited to 2.15 holding a wireless communications device. 2.16
- Subd. 2. **Prohibition on use; penalty.** (a) No When a motor vehicle is in motion or a 2.17 part of traffic, the person may operate a motor operating the vehicle while is prohibited 2.18 from using a wireless communications device, which includes but is not limited to: 2.19
