1.6	Section 1. Minnesota Statutes 2014, section 203B.01, subdivision 3, is amended to read:
1.7	Subd. 3. Military. "Military" means the Army, Navy, Air Force, Marine Corps,
1.8	Coast Guard or Merchant Marine of the United States, and all other uniformed services as
1.9	defined in United States Code, title 42, section 1973ff-6 52, section 20310, and military
1.10	forces as defined by section 190.05, subdivision 3.
1.11	Sec. 2. Minnesota Statutes 2014, section 203B.16, subdivision 1, is amended to read:
1.12	Subdivision 1. Military service; temporary residence outside United States.
1.13	Sections 203B.16 to 203B.27 provide alternative voting procedures for eligible voters who

Sections 203B.16 to 2.1 203B.27 provide the exclusive voting procedure for United States citizens who are living 2.2 indefinitely outside the territorial limits of the United States who meet all the qualifications 2.3 of an eligible voter except residence in Minnesota, but who are authorized by federal law 2.4 to vote in Minnesota because they or, if they have never resided in the United States, 2.5 a parent maintained residence in Minnesota for at least 20 days immediately prior to 2.6 their departure from the United States.
